

ARTICLES OF ORGANIZATION OF
T.A.A.R., LLC,
A LIMITED LIABILITY COMPANY
ORGANIZED UNDER THE LAWS OF THE STATE OF ALABAMA

The undersigned, acting as the organizer of a Limited Liability Company under the Alabama Liability Company Act ("The Act"), hereby adopts the following Articles of Organization for T.A.A.R., LLC, a Limited Liability Company, (hereinafter "Company").

1. The name of the company is T.A.A.R., LLC.
2. The Company shall continue in existence until it is dissolved in accordance with the provisions of the Operating Agreement or if there is no Operating Agreement or no provision in the Operating Agreement governing the duration of the Company, then in accordance with the Alabama Limited Liability Company Act, or other applicable laws.
3. The Company is organized for the purpose of owning and operating an insurance agency and engaging in any business that a limited liability company may engage in. The Limited Liability Company may engage in any and all lawful activities as may be necessary, incidental, or convenient to carry out the aforementioned purposes and business of the Limited Liability Company and may also pursue any other lawful activity permissible under the Act and approved by members of the Limited Liability Company.

ARTICLE ONE

NAME AND REGISTERED AGENT

1. The name of the Limited Liability Company is T.A.A.R., LLC (hereinafter referred to as "the Limited Liability Company").

2. The location and street address of the initial registered office of the Limited Liability Company shall be 16054 U S Highway 280, Suite 2, Chelsea, Alabama 35043, and its registered agent at such address will be Tyler Rutledge.

ARTICLE FOUR

CONTINUITY

If there are any remaining members of the Limited Liability Company after the death of Tyler Rutledge or after the dissolution, closing, or termination of any member's interest in the Limited Liability Company, those members will have the right to continue the Limited Liability Company on any event of disassociation which terminates the continued membership of a member in this Limited Liability Company.

ARTICLE FIVE

The affairs and business of the Limited Liability Company will not be centralized but will be conducted under the exclusive management of Tyler Rutledge who shall have exclusive authority to act for the Limited Liability Company in all matters.

ARTICLE SIX

NON-LIABILITY

Members shall not be personally liable for the debts, obligations, or liabilities of the Limited Liability Company.
