Subject to mineral and mining rights if not owned by Grantor.



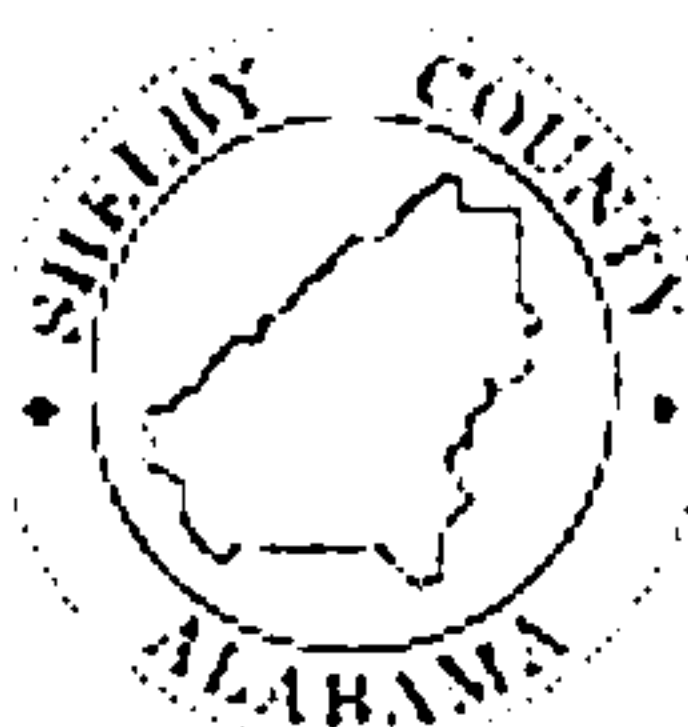
