

DOMESTIC NONPROFIT CORPORATION CERTIFICATE OF FORMATION

PURPOSE: In order to form a Nonprofit Corporation under Section 10A-1-3.05 and 10A-3-3.02 of the Code of Alabama 1975 this Certificate Of Formation and the appropriate filing fees must be filed with the Office of the Judge of Probate in the county where the corporation's initial registered office is located. The information required in this form is required by Title 10A.

INSTRUCTIONS: Mail one (1) signed original and two (2) copies of this completed form and the appropriate filing fees to the Office of the Judge of Probate in the county where the

corporation's registered office is/will be located. Contact the Judge of Probate's Office to determine the county filing fees. Make a separate check or money order payable to the Secretary of State for the state filing fee of \$100.00 and the Judge of Probate's Office will transmit the fee along with a certified copy of the Certificate to the Office of the Secretary of State within 10 days after the Certificate is issued. Once the Secretary of State's Office has indexed the filing the information will appear at under the Government Records tab and the Business Entity Records link – you may search by entity name. Your notification of filing was provided by the Probate Judge's Office via a stamped copy and the Secretary of State's Office does not send out a copy. You may pay the Secretary of State fees by credit card if the county you are filing in will accept that method of payment (see attached). Your corporation will not be indexed if the credit card does not authorize and will be removed from the index if the check is dishonored.

ARTICLES OF INCORPORATION

OF

A. BRAVE HEART Foundation

Pursuant to the provisions of The Code of Alabama and the Non-Profit Corporation Act of the State of Alabama, the undersigned hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of this corporation shall be A. BRAVE HEART Foundation.

ARTICLE II

DURATION

The period of duration is perpetual.

ARTICLE III

PURPOSES

A. BRAVE HEART Foundation, is a non-profit organization that has been organized exclusively for charitable, religious, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code.

More specifically, the organization serves the following purposes:

- 1. To engage in a nonprofit business in order to serve the community of cancer patients undergoing treatment. The organization aims to support the mental and physical health and wellness by providing therapeutic massage and care packages to patients in area hospitals via in-patients services; and
- 2. The organization may therefore seek, apply for and receive donations, grants, and other funding from individuals, organizations, corporations, governmental agencies, and others

to support and conduct in any manner, any lawful activities in furtherance of these charitable purposes.

ARTICLE IV



ARTICLE VII

No part of the net earnings of the organization shall inure to the benefit of or be distributable to its members, officers, trustees, or other private person, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in or intervene including the publishing and distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of the articles, this organization shall not, except to an insubstantial degree, engage in any activities or exercise any powers that these articles do not grant. This organization shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, are not in furtherance of the purpose of the organization.

ARTICLE VIII

DISSOLUTION

The initial incorporator/ board director shall have the right to dissolve A. BRAVE HEART Foundation. at any time. Upon dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
