The undersigned acting as the organizers of a limited liability company under the Alabama Limited Liability Company Act (the "Act"), hereby adopt the following Articles of Organization for BT Tow and Recovery LLC hereinafter called the "Company").

1. The name of the Company is BT Tow and Recovery LLC, Limited Liability Company (L.L.C.).
2. The Company shall continue in existence until it is dissolved in accordance with the provisions of the operating agreement, or, if there is no operating agreement or no provision in the operating agreement governing the duration of the Company, then in accordance with the Alabama Limited Liability Company Act, or other applicable laws.
3. The Company is organized for the purpose of repairing, towing, storage, and maintenance of automobiles, as well as, any other lawful business enterprise or activity therewith.
4. The mailing address of the initial registered office shall be 11544 Highway 280, Westover, Alabama 35186, and the name of the initial registered agent of the Company at such address is Mike Taylor.
5. The names and addresses of the initial members of the Company are:

6. The initial members of the Company may admit additional members at such times and upon such terms and conditions as may be agreed by the Company and the additional members.
7. The legal existence and business of the Company may be continued by the written consent of all the remaining members within 30 days after an event of disassociation of a member.

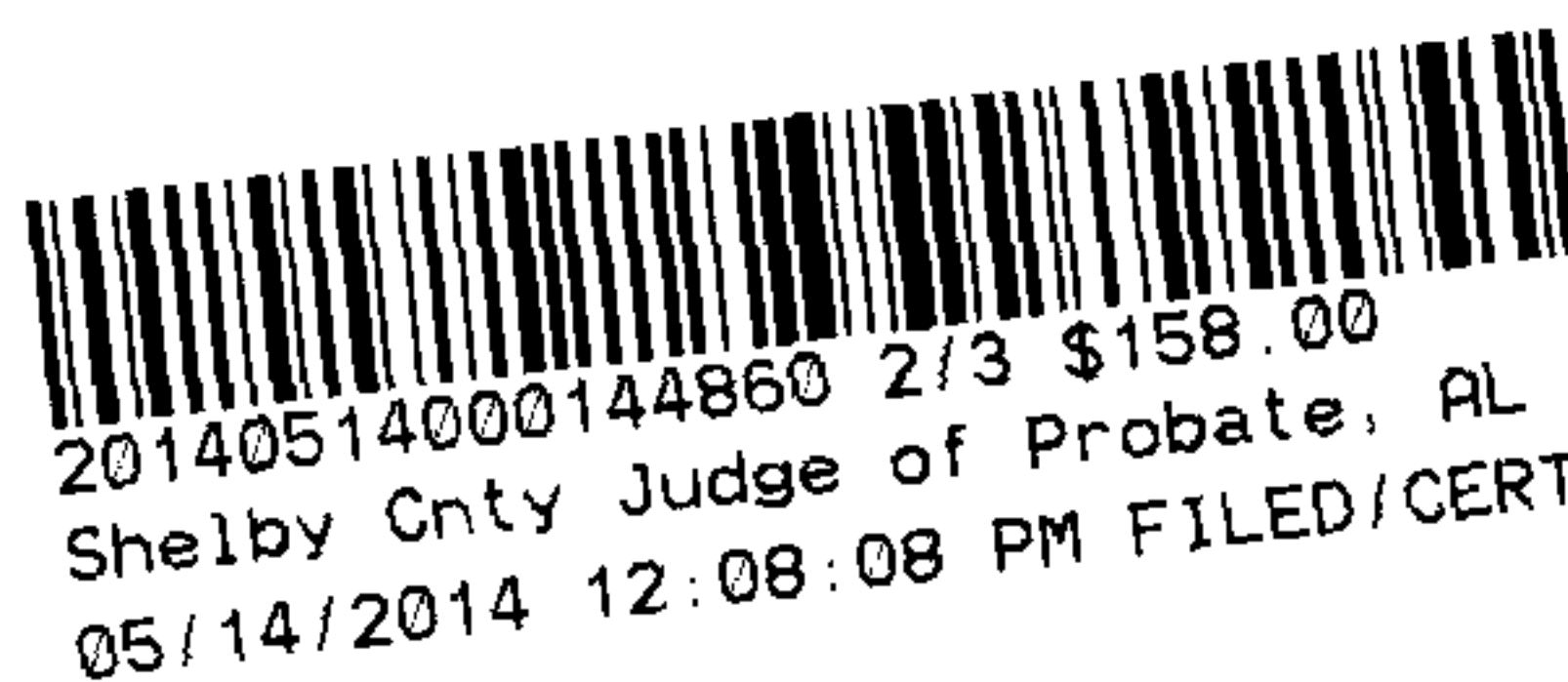
