KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 13th day of November, 2007, Richard S. Findley, married and Randi Findley, a married woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Bluestar Mortgage, Inc., a Alabama Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20071126000536770; modified by Loan Modification Agreement recorded in Instrument Number 20130408000145380, said mortgage having subsequently been transferred and assigned to Nationstar Mortgage, LLC., by instrument recorded in Instrument Number 20110909000266860, in the aforesaid Probate Office ("Transferee"); and

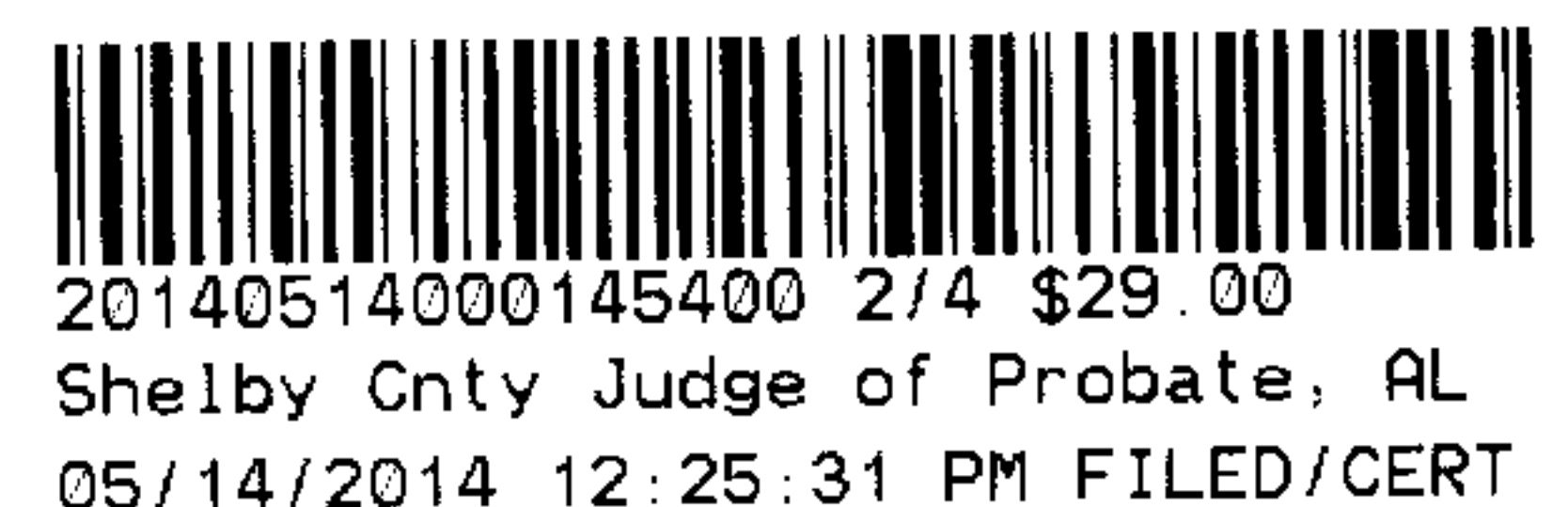

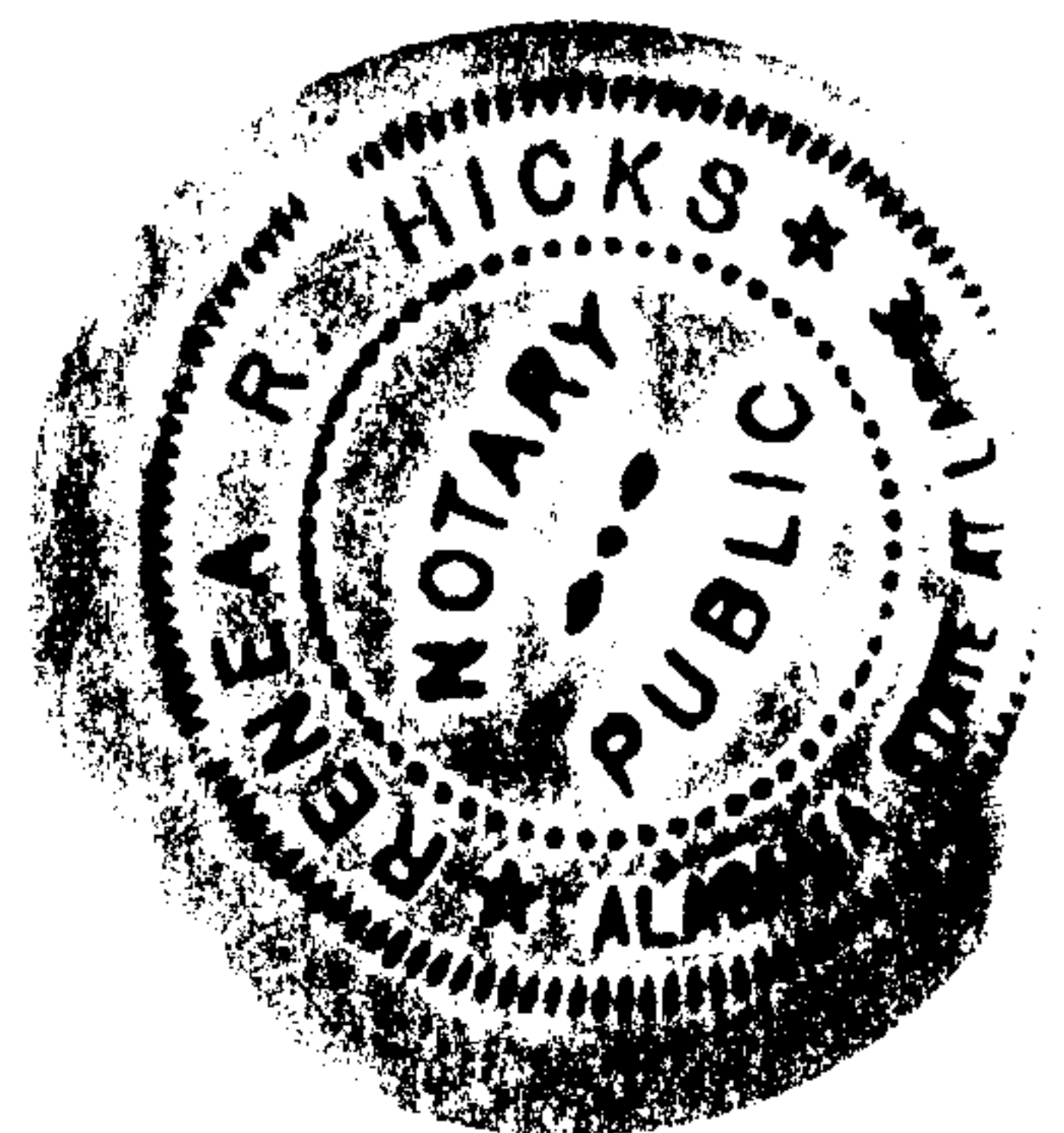
