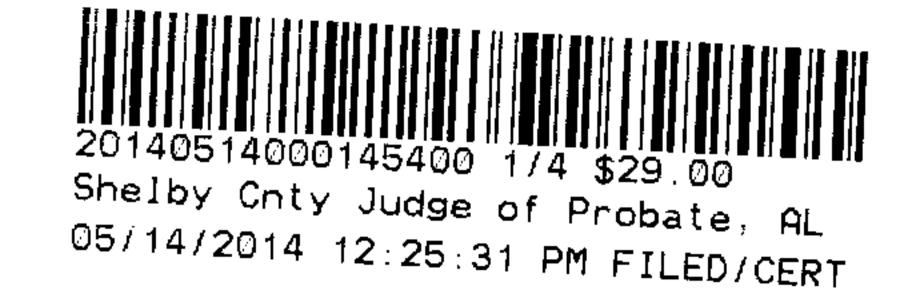

WHEREAS, heretofore, on, to-wit: the 13th day of November, 2007, Richard S. 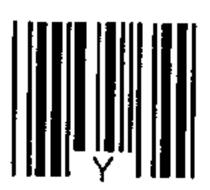

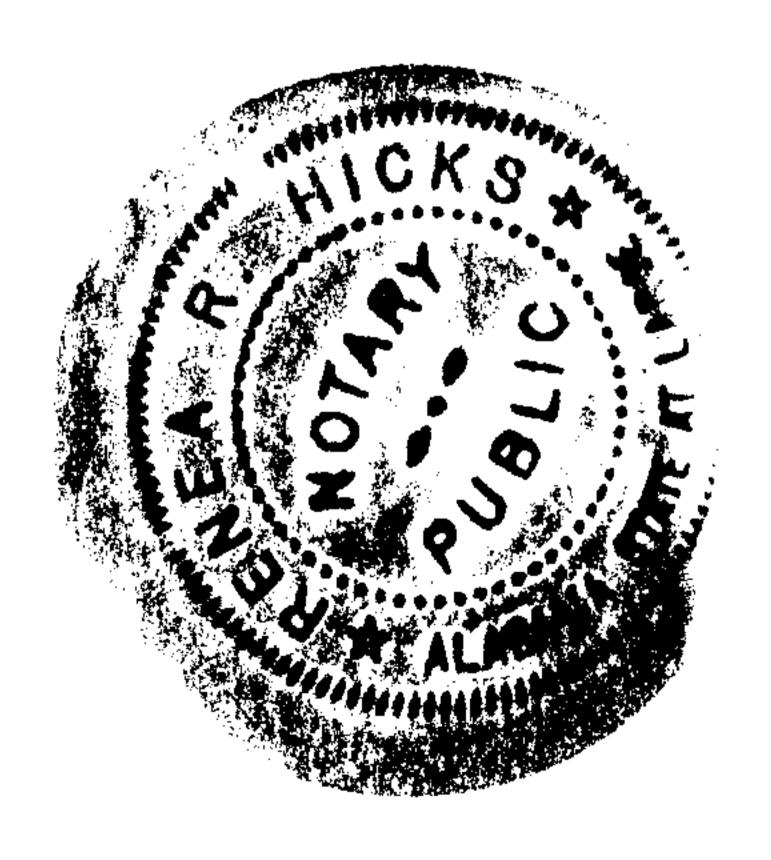
