FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 29th day of May, 2003, Charanjeet K. of general circulation published in Shelby County, Alabama, in its issues of November 6, 2013, November 13, 2013, and November 20, 2013; and

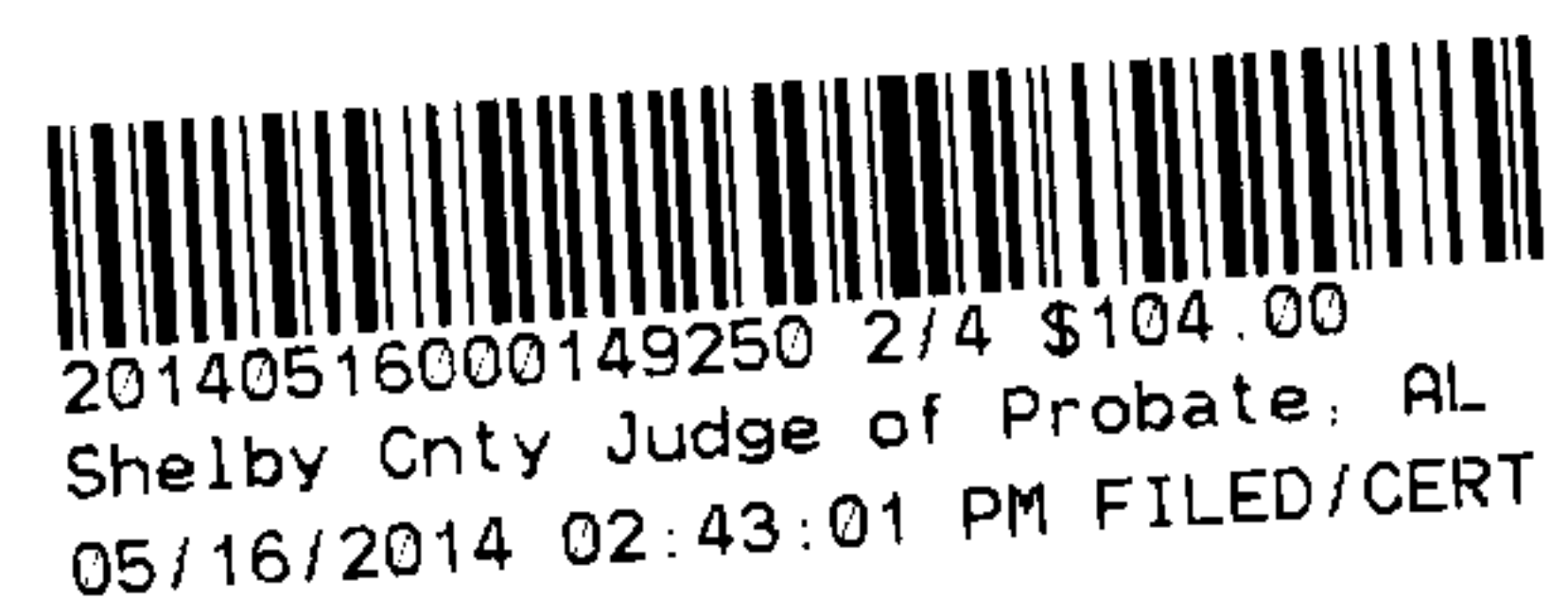
