JOHN R. WYNN AND JOANN B. WYNN, TRUSTEES, OR THEIR SUCCESSORS IN TRUST, UNDER THE WYNN LIVING TRUST, DATED APRIL 22, 2014, AND ANY AMENDMENTS THERETO.

(herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:
