THIS TERMINATION OF AGREEMENT REGARDING TRANSFERS AND ENCUMBRANCES ("Termination Agreement") is made as of May 13, 2014 by WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association ("Wells"), for the benefit of GRAY PROPERTY 7102, LLC, a Virginia limited liability company, GRAY LUMBER COMPANY, a Virginia corporation, and GRAYLAND COMPANY, L.P., a Virginia limited partnership, as tenants in common (collectively, "Gray").
