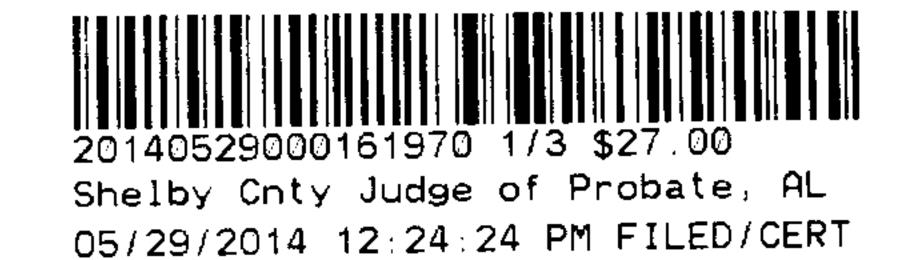

MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS: That THOMAS A. WHITTEN and TAMMY L.
