KNOW ALL PERSONS BY THESE PRESENTS: That MAUREEN E. HINTON, an unmarried woman, did, on to-wit, October 26th, 2009, execute a mortgage to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for GMFS, LLC, which mortgage is recorded in Instrument No. 20091104000413100, et seq., in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage being lastly assigned to BANK OF AMERICA, N.A. by instrument recorded in Instrument No. 20140314000070880 in said Probate Court records; and
