KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 17th day of November, 2008, James M. Webster, Jr. and Tiffany D. Webster, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Primary Capital Advisors, LC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20081117000442480; said mortgage having subsequently been modified by Loan Modification Agreement filed for record in Instrument Number 20130327000127520, said mortgage having subsequently been transferred and assigned to MidFirst Bank, a Federally Chartered Savings Association, by instrument recorded in Instrument Number 20140122000020930, in the aforesaid Probate Office ("Transferee"); and
