

ARTICLES OF ORGANIZATION OF CRITERION CHEMISTRIES, LLC

The undersigned, for the purpose of forming a limited liability company under the Alabama Limited Liability Company Law (Ala. Code § 10A-5-1.01, et seq.) or any act amendatory thereof, supplementary thereto, or substituted therefore (hereinafter known as the "Act"), does hereby adopt as its certificate of formation the following Articles of Organization:

ARTICLE I NAME

The name of the limited liability company is Criterion Chemistries, LLC (hereinafter known as the "Company"). This name was reserved with the Alabama Secretary of State on May 30, 2014, as shown by the certificate attached hereto.

ARTICLE II DURATION

The period of duration of the Company shall be perpetual from the date of the filing of these Articles of Organization. The Company shall remain in existence until it is dissolved in accordance with the provisions of the Operating Agreement, or, if there is no provision in the Operating Agreement governing the duration of the Company, then in accordance with the Alabama Limited Liability Company Law.

ARTICLE III PURPOSES

The purposes for which the Company is organized are as follows:

- A. To establish and carry on the business of providing clinical consulting services and the manufacturing and distribution of custom and standard chemical reagents;
- B. To engage in any and all transactions which are necessary, appropriate, convenient, or incidental to accomplish the business purposes stated herein;
- C. To engage in any or all lawful business for which limited liability companies may be organized under the Act.

ARTICLE IV PRINCIPAL OFFICE

The location and mailing address of the Company's initial principal office will be at 1709 Woodview Circle, Pelham, Alabama 35124. Future location/s and mailing address/es of the Company's principal office may be determined by the members in compliance with the Act and applicable provisions of the Company's Operating Agreement, if any.

ARTICLE V REGISTERED OFFICE AND AGENT

The location and mailing address of the initial registered office of the Company for purposes of service of process within the State of Alabama will be at 1709 Woodview Circle, Pelham, Alabama 35124. The initial registered agent for purposes of service of process within the State of Alabama at the foregoing address will be Mary C. Long. A new registered office and/or registered agent may be designated by the members from time to time and in compliance with Ala. Code § 10A-1-5.32 and applicable provisions of the Company's Operating Agreement, if any.



ARTICLE VIII ADDITIONAL MEMBERS

Additional members may be admitted in accordance with the terms of the Company's Operating Agreement, if any. If the Company does not have an operating agreement that



provides for the admission of additional members, additional members may be admitted with the unanimous written consent of the then-existing members at such times and upon such terms and conditions as may be mutually agreed upon by the members and the person desiring to become a member.

ARTICLE IX MANAGEMENT

Pursuant to the Act, the Company's management shall be vested in its members and they shall have the right and authority to manage the business or affairs of the Company and to make all decisions with respect thereto.

ARTICLE X CONTINUATION OF THE COMPANY

In the event there are no remaining members, and except as otherwise provided in the Company's Operating Agreement, if any, the Company shall be dissolved and its affairs shall be wound up unless:

- A. The holders of all of the financial rights in the Company agree in writing within ninety (90) days after the cessation of membership of the last member, to continue the legal existence and business of the Company and to appoint one or more new members; or
- B. The legal existence and business of the Company is continued and one or more new members are appointed in the manner stated in an operating agreement of the Company.

For the purpose of this Article, all of the financial rights owners means interests of one or more remaining financial rights owners which, when taken together, own one hundred percent (100%) of the capital interests and one hundred percent (100%) of the profits interests of the remaining financial rights owners.

ARTICLE XI AMENDMENT OF ARTICLES OF ORGANIZATION

These Articles of Organization may be amended only by the unanimous vote or written consent of all of the members of the Company.

ARTICLE XII INCORPORATION OF PROVISIONS OF OPERATING AGREEMENT

The provisions of the Company's Operating Agreement, if any, are incorporated herein by reference as though fully set forth herein.


ARTICLE XIII CESSATION OF MEMBERSHIP


