ADMISSION OF NEW MEMBERS

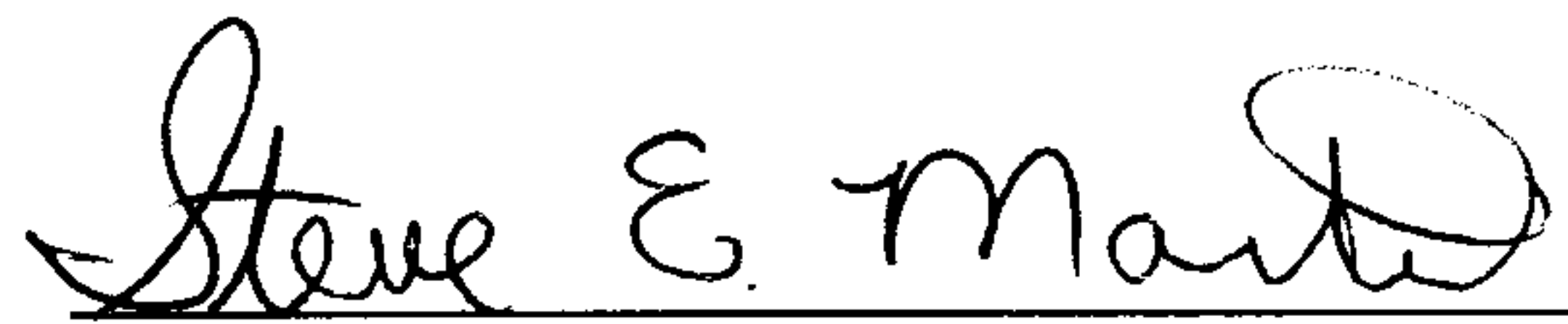
