WITH REMAINDER TO SURVIVOR

Know all Men by these Presents: That, in consideration of One Hundred Twelve Thousand and No/100ths Dollars (\$112,000.00) and other good and valuable consideration to them in hand paid by the Grantee herein, the receipt of which is hereby acknowledged, **WILLIAM C. JONES, III AND LISA A. JONES, Husband and Wife** (herein referred to as "Grantors") do by these presents grant, bargain, sell and convey unto **REBECCA JAMES and ALEX JAMES** (herein referred to as "Grantee") for and during their joint lives and, upon the death of either of them, then to the survivor, in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 10, according to the survey of Park Place as recorded in Map Book 15, page 47, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.


This conveyance is subject to subdivision restrictions, utility, drainage and sewer easements, and minimum setback lines, if any, applicable to the aforesaid property appearing of record in the Office of the Judge of Probate of Alabaster, Shelby County, Alabama. This conveyance is also subject to any prior reservation, severance or conveyance of minerals or mineral rights and the following:

1. Building Setback line of 35 feet reserved from Warrior Drive, as shown per plat.
2. Utility easements as shown by recorded plat, including, 7.5 feet along the rear.
3. Restrictions, covenants, and conditions as set out in Real Book 351, page 235, in Probate Office, but omitting any covenants or restrictions, if any, based upon race, color, religion, sex, sexual orientation, familial status, marital status, disability, handicap, national origin, ancestry, or source of income, as set forth in applicable state or federal laws, except to the extent that said covenant or restriction is permitted by applicable law.
4. Restrictions, limitations and conditions as set out in Plat Book 15, page 47, in the Probate Office of Shelby County, Alabama.
5. Transmission Line Permit(s) granted to Alabama Power Company as shown by instrument(s) recorded in Real 84, page 189 and Deed Book 333, page 385, in Probate Office.
6. Right(s)-of-Way(s) granted to Shelby County, as set out in Deed Book 216, page 584, in the Probate Office.
7. Right(s)-of-Way(s) granted to Southern Natural Gas Co., as set out in Deed Book 88, page 557, in the Probate Office.
8. Easement(s) granted to Plantation Pipeline Co. as set out in Deed Book 210, page 150, in the Probate Office.

To Have and To Hold the aforegranted premises to the said Grantee for and during their joint lives and, upon the death of either of them, then to the survivor, in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion.

And the said Grantors do, for themselves, their heirs and assigns, covenant with said Grantee, her heirs and assigns, that they are lawfully seized in fee simple of said premises, that it is free from all encumbrances, except as otherwise noted above, that they have a good right to sell and convey the same as aforesaid, and that they will and their heirs and assigns shall **Warrant and Defend** the premises to the said Grantee, her heirs, personal representatives and assigns forever, against the lawful claims of all persons.





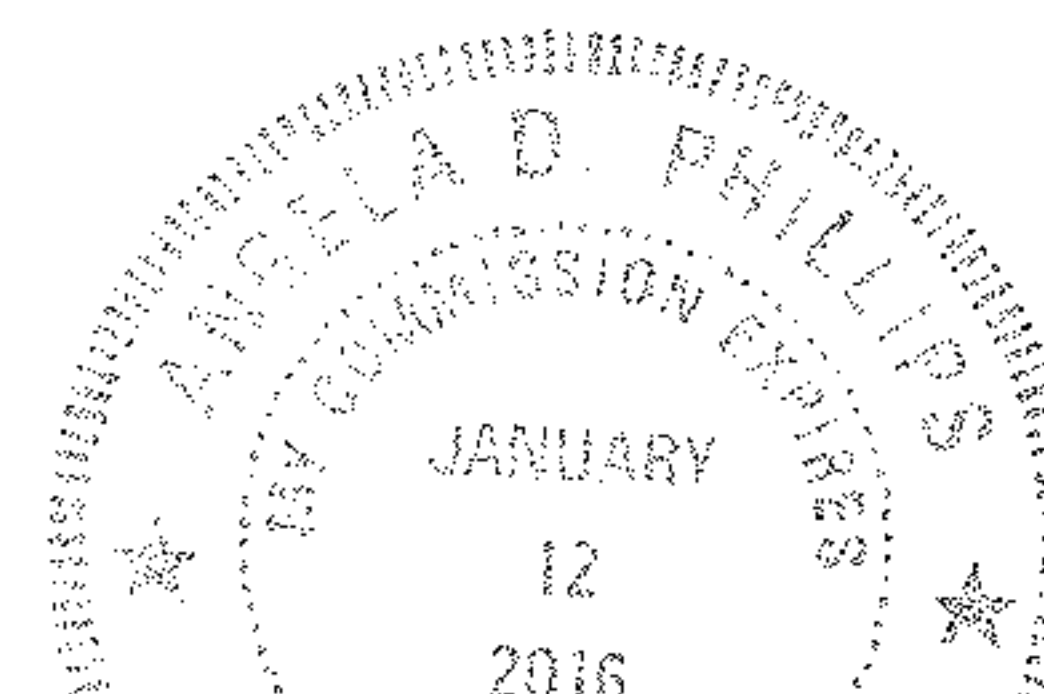
