

# ARTICLES OF ORGANIZATION

OF

## OROZCO PAINTING, LLC

I, the Undersigned, desiring to form a limited liability company (the "Company") pursuant to the provisions of Act No. 93-724 of the 993 Alabama Legislature, as subsequently amended, known as the Alabama Limited Liability Company Act (the "Act"), as amended, for the purposes hereinafter stated, hereby adopt the following Articles of Organization:

### ARTICLE I

**NAME OF COMPANY:** The name of the Company shall be Orozco Painting, LLC.

### ARTICLE II

**DURATION:** The existence of the Company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and shall continue in perpetuity: provided, however, that the Company shall be dissolved (a) upon the written consent of all of the members: (b) as provided in the Operating Agreement of the Company: or (c) as may be required by the Act, as the same may be amended from time to time.

### ARTICLE III

**PURPOSES:** The purpose for which the Company is formed is as follows:

To establish, develop, own, operate, and maintain a business and facility for the provision of services to the public.

The Company may also engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act. The Company shall have the authority to do all things necessary or convenient to accomplish its purposes and operate its business.

### ARTICLE IV

**REGISTERED OFFICE AND AGENT:** The location and mailing address of the Company's initial registered office is 824 Springs Ave, Birmingham, AL 35242. The name of the Company's initial registered agent at such address is Erika Oregel Olguin.

## ARTICLE V
