CERTIFICATE OF FORMATION
OF
MELROSE RENOVATION, LLC

The undersigned, for the purpose of forming a limited liability company under Sections 10A-1-3.05 and 10A-5-2.02 of the Code of Alabama (1975), as amended (the "Alabama Limited Liability Company Law"), hereby file the following Certificate of Formation with the probate judge of the county in which the initial registered agent of the limited liability company will be located and affirm that the facts stated in this Certificate of Formation is true and correct:

ARTICLE I

The name of the limited liability company is **Melrose Renovation, LLC** (the "Company").

ARTICLE II

The period of duration of the Company shall be perpetual beginning on the date of filing of this Certificate of Formation with the Office of the Probate Judge for Shelby County, Alabama. Provided, however, that the Company shall be dissolved (a) as provided in the Operating Agreement, as amended from time to time, or (b) as may be required by the Alabama Limited Liability Company Law.

ARTICLE III

The purpose or purposes for which the Company is organized are as follows:

The transaction of any and all lawful business (except that the Company shall not be engaged in the business of banking) for which limited liability companies may be organized under the Alabama Limited Liability Company Law, including, but not limited to, any and all transactions and business activities which are necessary, appropriate or incidental to the acquisition, construction, renovation, lease and/or sale of real property.

ARTICLE IV

The location and mailing address of the initial registered office of the Company shall be 5101 Cyrus Circle, Birmingham, Alabama 35242. The initial registered agent for service of process at the foregoing address shall be Kevin R. Gann.

ARTICLE V

The name and mailing address of the initial member of the Company is as follows:

ARTICLE VI

The initial members shall have no right to admit additional members, except in accordance with the Operating Agreement, as amended from time to time.

ARTICLE VII

The members of the Company shall have the right to continue the business of the Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member of the Company if (i) there is at least one remaining member; or (ii) there is no remaining member, and the holders of all the financial rights in the Company agree in writing, within 90 days after the cessation of membership of the last member, to continue the legal existence and business of the Company and to appoint one or more new members, or (iii) the legal existence and business of the Company is continued and one or more new members are appointed in the manner stated in the Operating Agreement or Certificate of Formation.

ARTICLE VIII

The Company shall be managed its members.

ARTICLE IX

The following person shall serve as the organizer of the Company and shall execute and file this document with the Office of the Judge of Probate of Shelby County, Alabama:

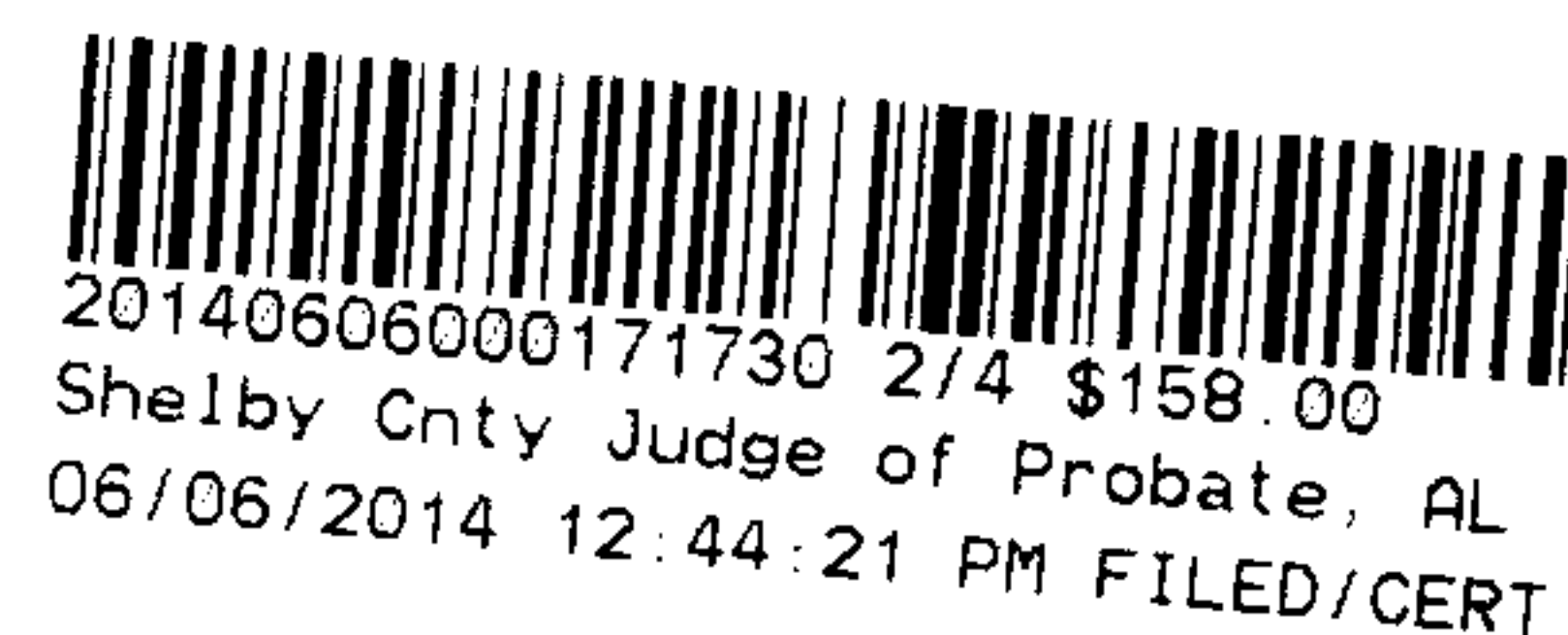

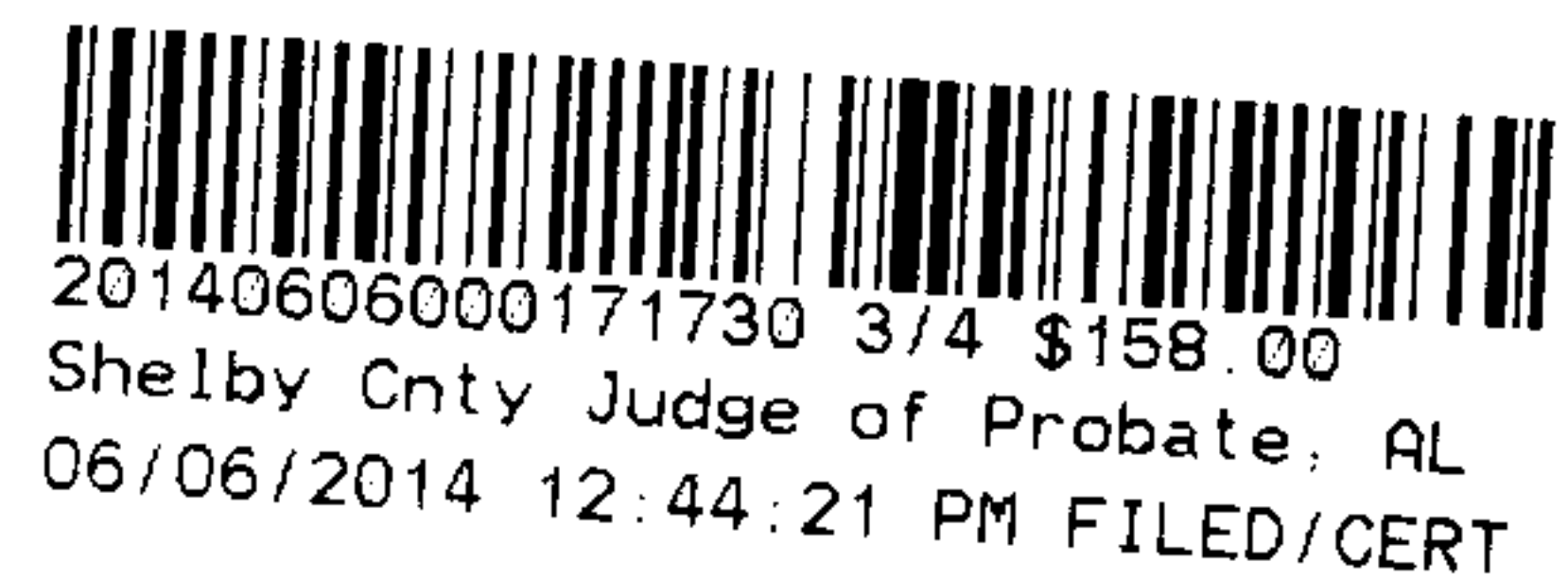
