

FORECLOSURE DEED

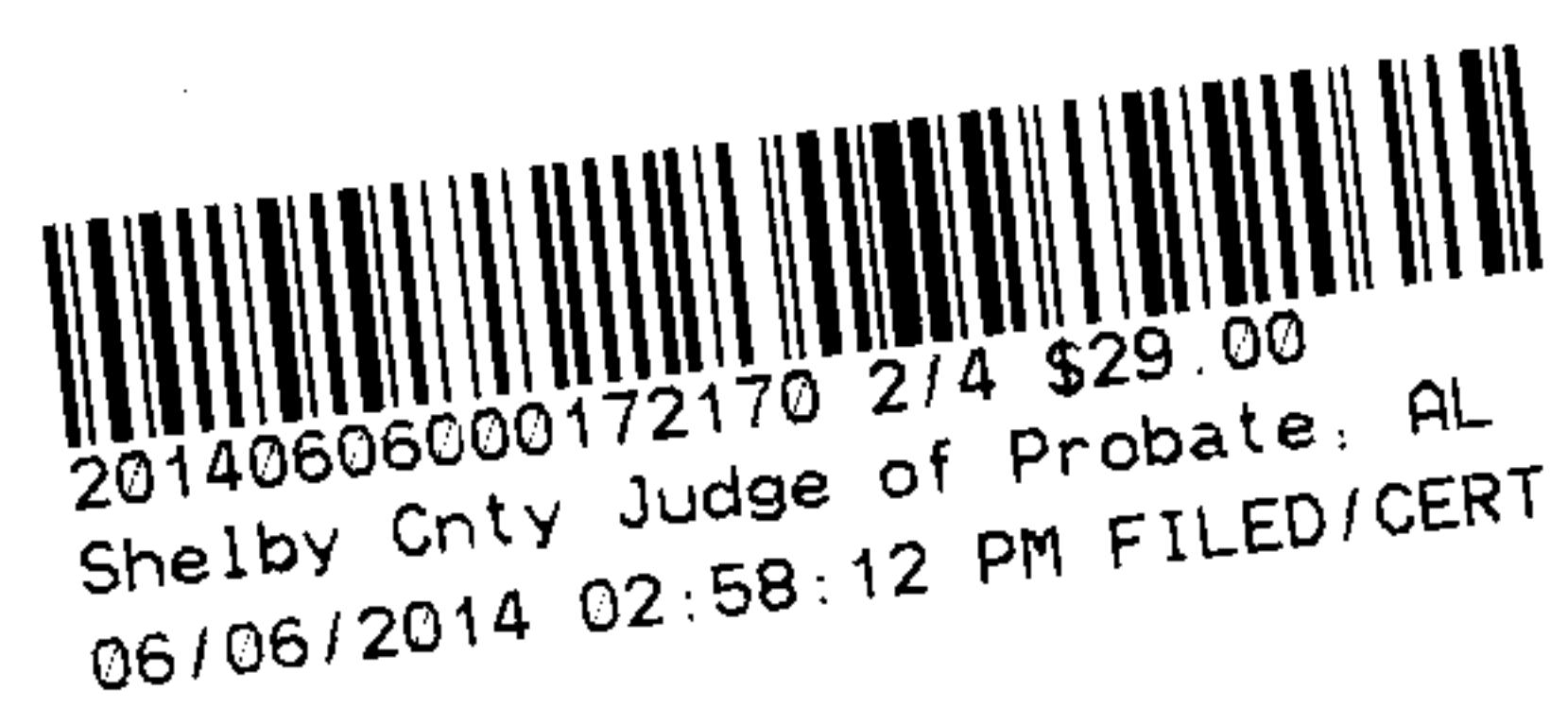
KNOW ALL MEN BY THESE PRESENTS, That where as heretofore on January 28, 2005, Stefanie Hereford, an unmarried woman, executed a certain mortgage on the property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for The Bank, a Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, at Instrument Number 20050201000047180; and subsequently transferred and assigned to Bank of America, N.A, and said assignment being recorded in Instrument number 20111018000309620; and subsequently transferred and assigned to Christiana Trust, a division of Wilmington Savings Fund Society, FSB, not in its individual capacity but as Trustee of ARLP Trust 3, and said assignment being recorded in Instrument number 20140404000097500;

WHEREAS, in and by said mortgage the mortgagee was authorized and empowered in
