KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 29th day of September, 2011, Jamie Lee Hastings and Jennifer Hastings, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Hamilton Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument number 20111005000296230, said mortgage having subsequently been transferred and assigned to U.S. Bank National Association, by instrument recorded in in Instrument Number 20140210000037390, in the aforesaid Probate Office ("Transferee"); and

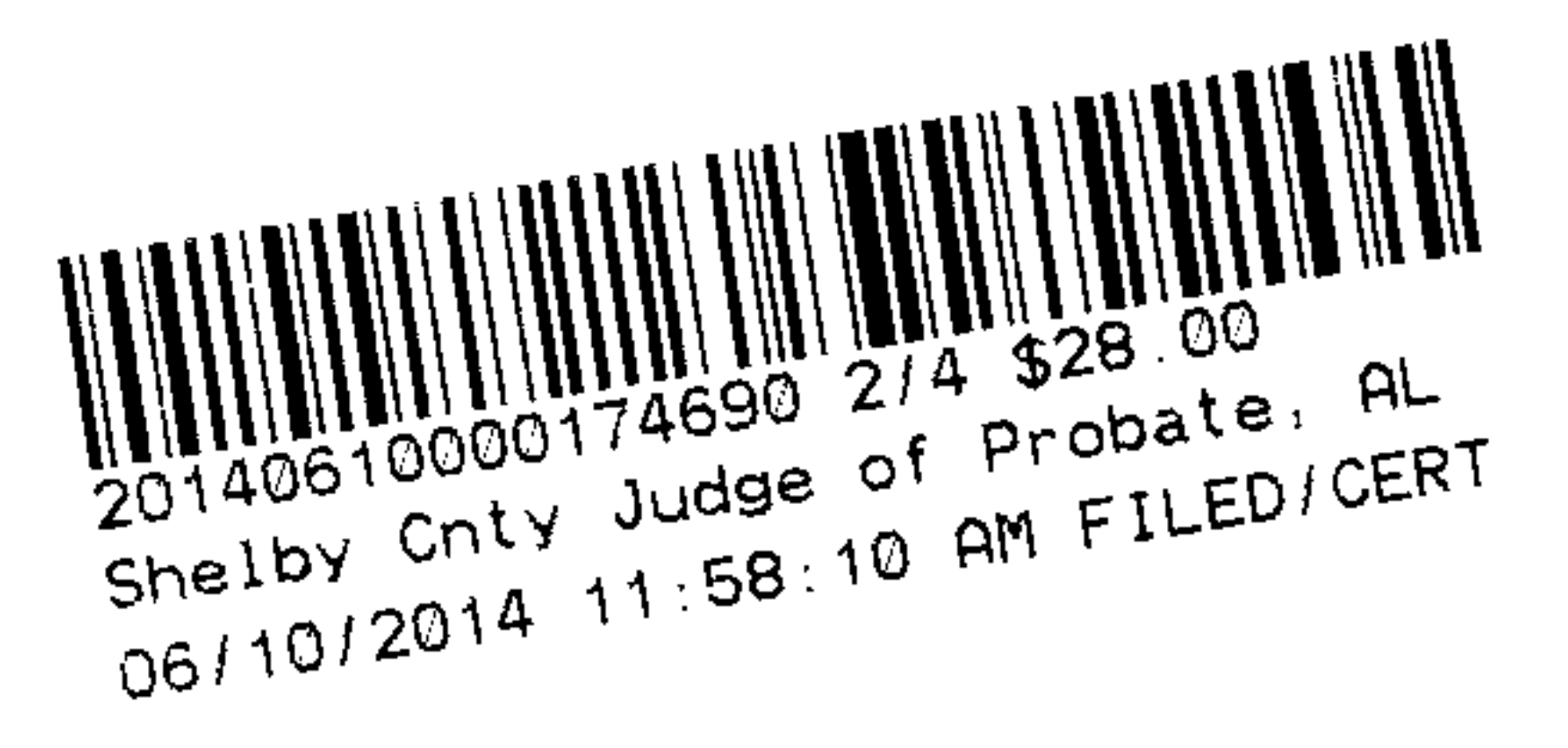

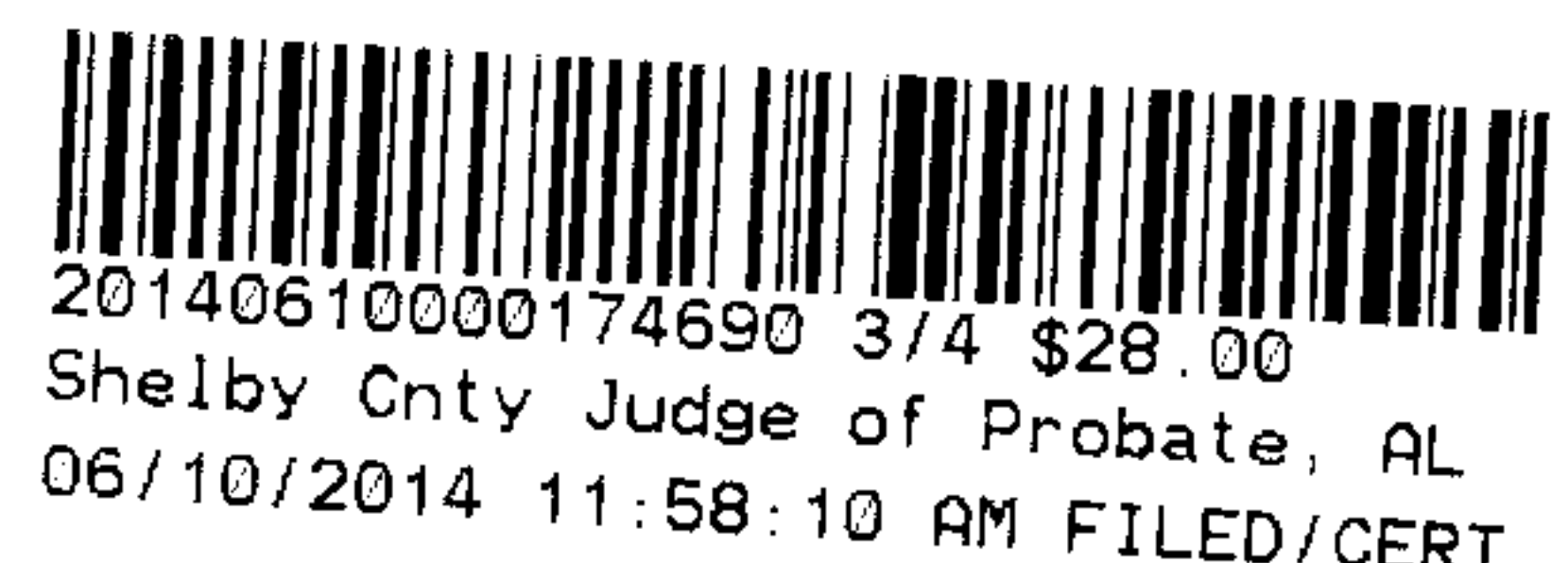
