KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 23rd day of February, 2009, Wendall L. Jackson, Jr., a single man and Wendell L. 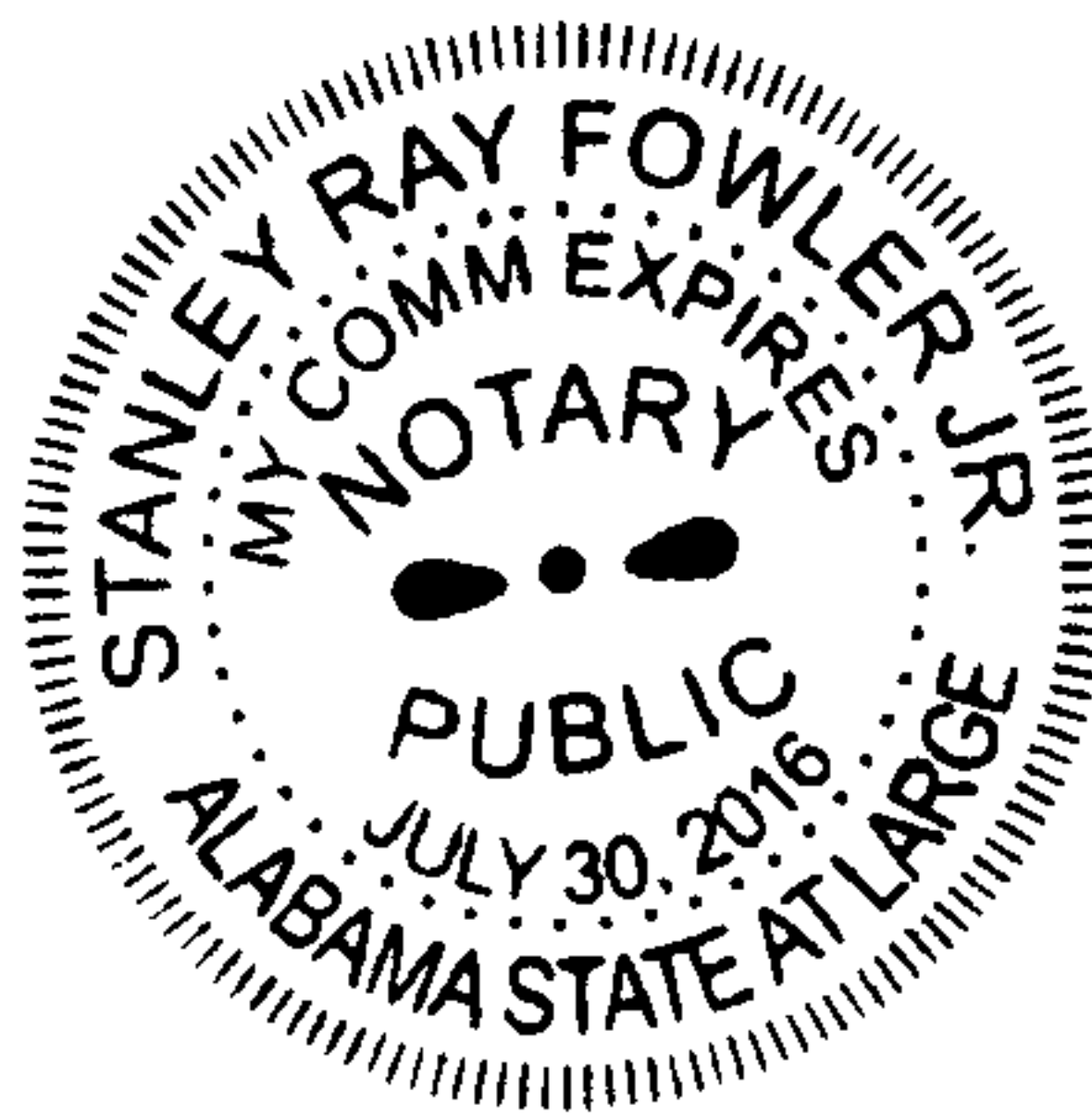
