KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of THREE HUNDRED SEVENTY-SEVEN THOUSAND AND NO/100 DOLLARS (\$377,000.00) and other good and valuable consideration, this day in hand paid to the undersigned Grantors, **MARCY ANN WILLIAMS fka MARCY ANN STIPP and L. GEORGE WILLIAMS, wife and husband** (hereinafter referred to as Grantors), the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **BEN BRAND and CARI BRAND** (hereinafter referred to as Grantees), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, their heirs and assigns, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 3512, according to the Survey of Riverchase Country Club, 35<sup>th</sup> Addition, as recorded in Map Book 16, Page 113, in the Probate Office of Shelby County, Alabama.

Subject to rights-of-way, covenants, restrictions, easements, agreements, setback lines, reservations, mineral/mining rights, and declarations of record, if any.


\$358,150.00 of the above-recited purchase price was paid with a purchase money mortgage being recorded simultaneously herewith.


