
Megan Boullion is one and the same person as Megan McConville as reflected in that certain deed recorded in Instrument No. 20060602000262080 in said Probate Office.

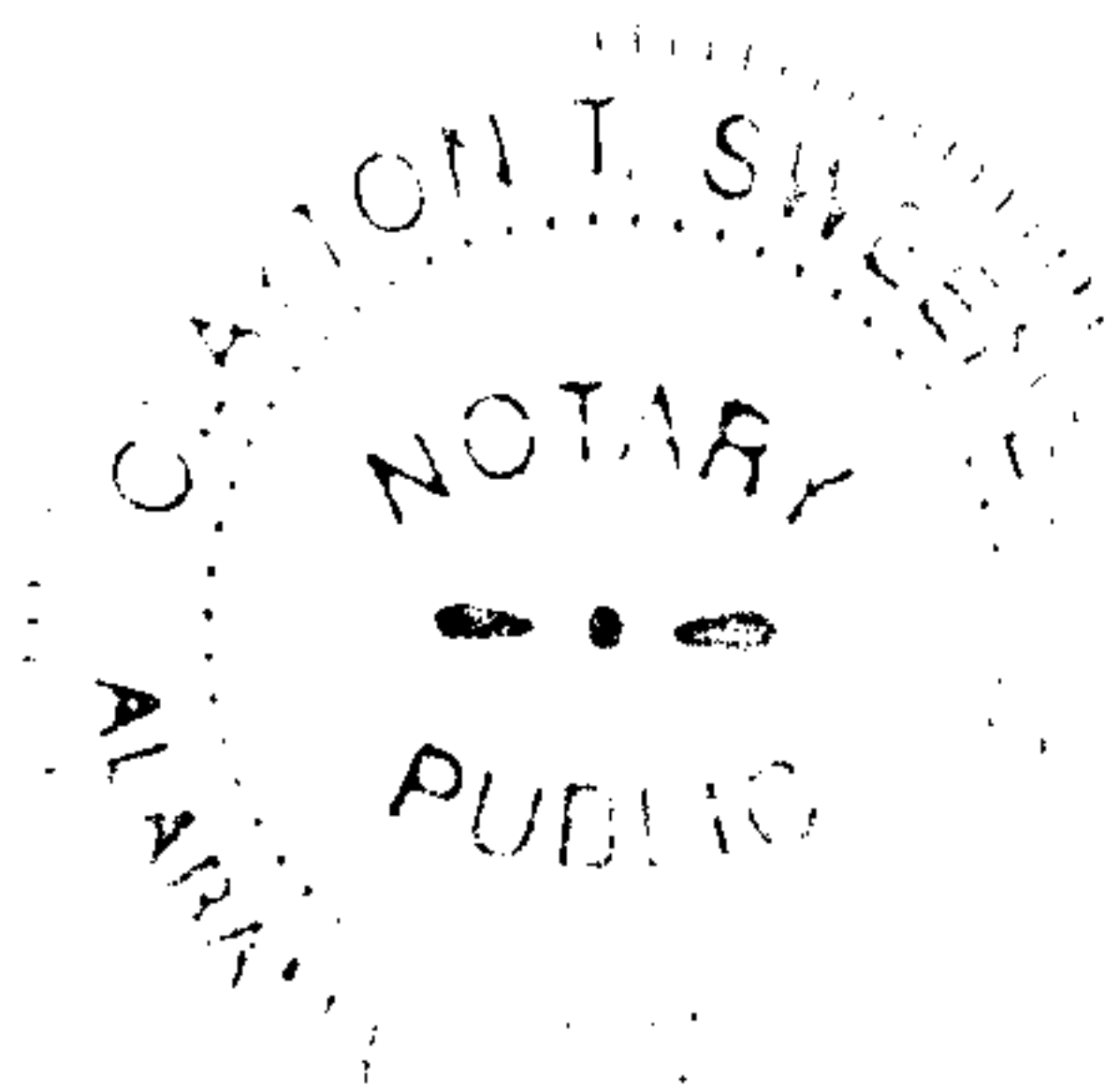
