
consent of the other member except for the event of death of one of the members. The surviving member will have rights to all assets, debts and decision making.

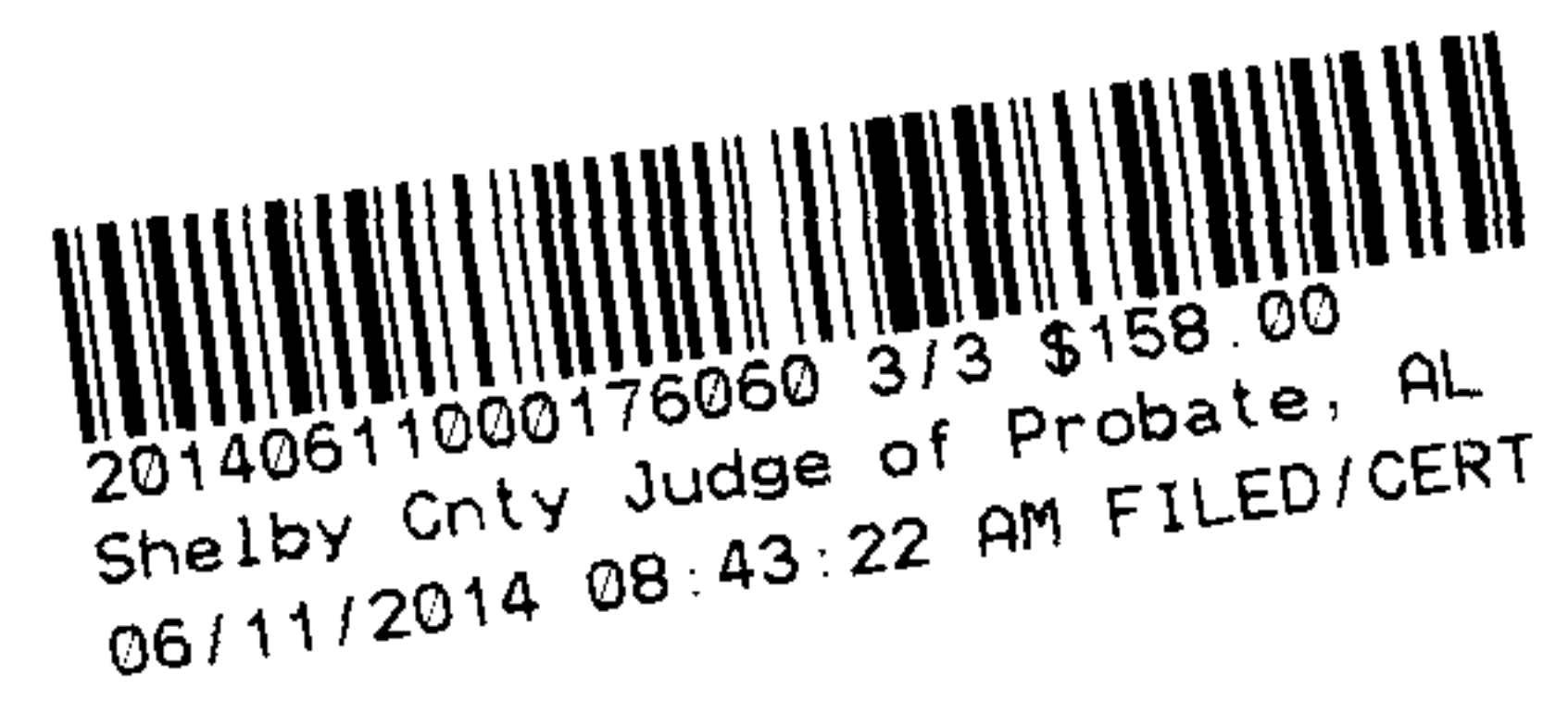
