

**ARTICLES OF ORGANIZATION
OF

Pursuant to the provisions of Act No. 93-724 of the 1993 Alabama Legislature, the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

ARTICLE I

**THE NAME OF THE LIMITED LIABILITY COMPANY IS:
NO WORRIES, LLC**

ARTICLE II

DURATION

The period of duration is perpetual.

ARTICLE III

PURPOSES

The Limited Liability Company has been organized for the following purposes:

- (a) To function as a holding company of other organizations, companies and legally recognized entities as entered into by agreement between the member(s) of the Limited Liability Company.
- (b) To enter into, make and perform contracts and agreements of every kind for every lawful purpose with any person, firm, corporation, municipality or political body, whether related to the above described businesses or not.
- (c) To do all things necessary, suitable and proper for the accomplishments of any of the purposes or attainment of any of the objects, or the furtherance of any of the powers hereinabove set forth, either alone or in association of other corporations, firms, limited liability companies, or individuals, and to do every other act or acts, thing or things, incidental or appurtenant to, or growing out of, or connected with the aforesaid business or powers or any part or parts thereof, providing the same is not inconsistent with the laws under which this Limited Liability Company is organized.
- (d) This Limited Liability Company is organized for the purpose of conducting any or all lawful businesses allowed under the Alabama Limited Liability Company Act, Act number 93-724 of the Alabama Legislature.

The foregoing clauses shall be construed as purposes and powers and nothing herein shall be deemed to limit or exclude in any manner any right, power or privilege given to the Limited Liability Company by law or the authority which it is or might be permitted to exercise under the laws of the State of Alabama.

ARTICLE IV

REGISTERED AGENT'S OFFICE

The location and street address of the initial registered office shall be 4904 Whispering Lake Circle and its registered agent at such address shall be Noah R. Crawford.

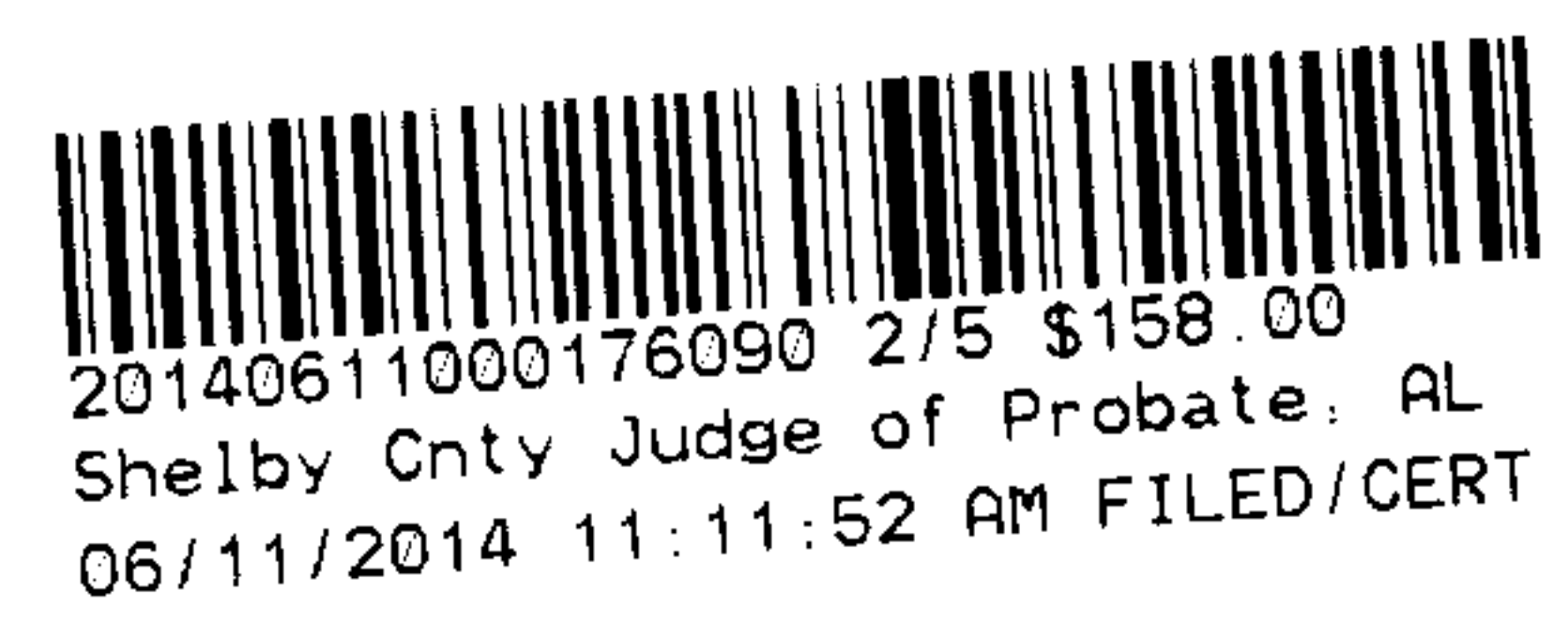

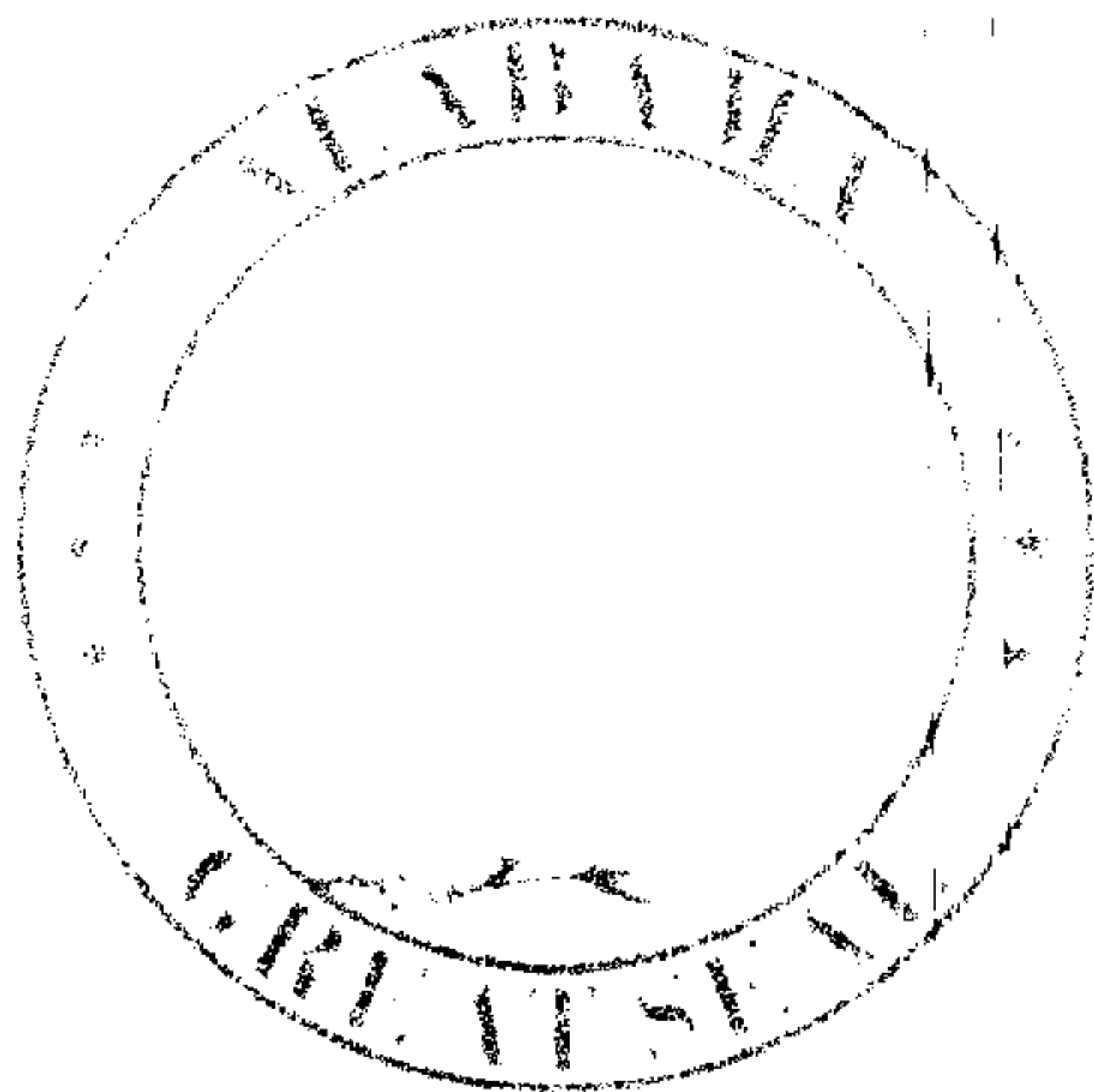
