That in consideration of the sum of **Two Hundred Thirty Two Thousand Five Hundred Dollars and No Cents (\$232,500.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **William S. Robinson and Antionette Robinson**, husband and wife (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Dennis Lee Tremelling and Mary C. Tremelling**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;


