

**CERTIFICATE OF FORMATION
OF

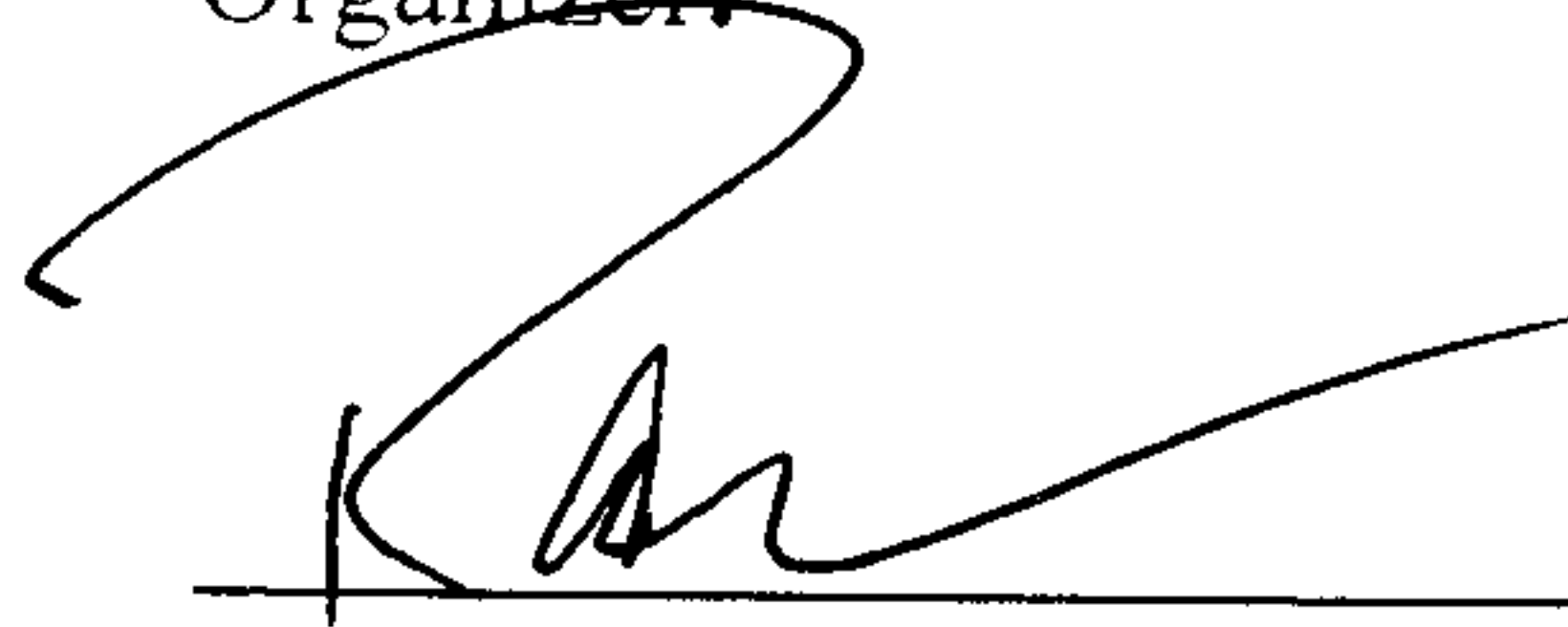
7. The Company has the right to admit members to the Company in accordance with the terms and conditions of the applicable provisions of the Operating Agreement of the Company.

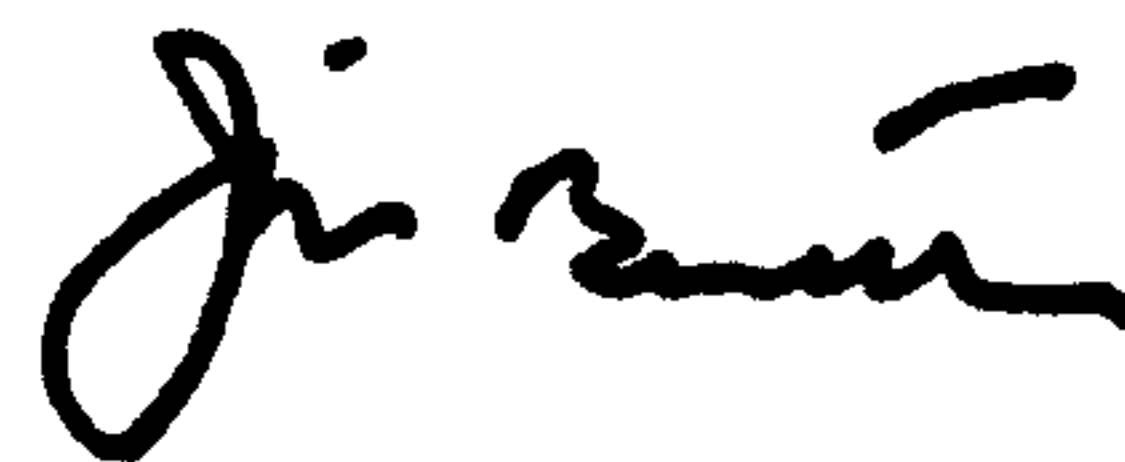
