
ARTICLES OF AMENDMENT TO THE

AMENDED ARTICLES OF INCORPORATION OF

PROCESS SPECIALTIES, INC., an Alabama corporation (the "Corporation")



Pursuant to the provisions of Sections 10A-2-10.01 through 10A-2-10.09 of the *Code of Alabama* (1975), as amended, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation, as amended (the "Articles") as of June 6, 2014:

- 1. The name of the Corporation is Process Specialties, Inc.
- 2. The Articles of Incorporation of the Corporation were filed with the Office of the Judge of Probate of Jefferson County, Alabama on February 12, 1975. The Articles of Incorporation were amended by Articles of Amendment on June 25, 1999.
- 3. For purposes of changing the name of the Corporation, Article I of the Corporation's Articles is hereby deleted in its entirety and the following is substituted in lieu thereof:

The name of the corporation shall be BMWR, Inc. (the "Corporation").

- 4. The above amendment to the Articles was adopted and approved by the Board of Directors and Shareholders of the Corporation as of June 6, 2014.






