KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 8th day of September, 2004, Liza A. Sipe, a married woman, and Amy L. 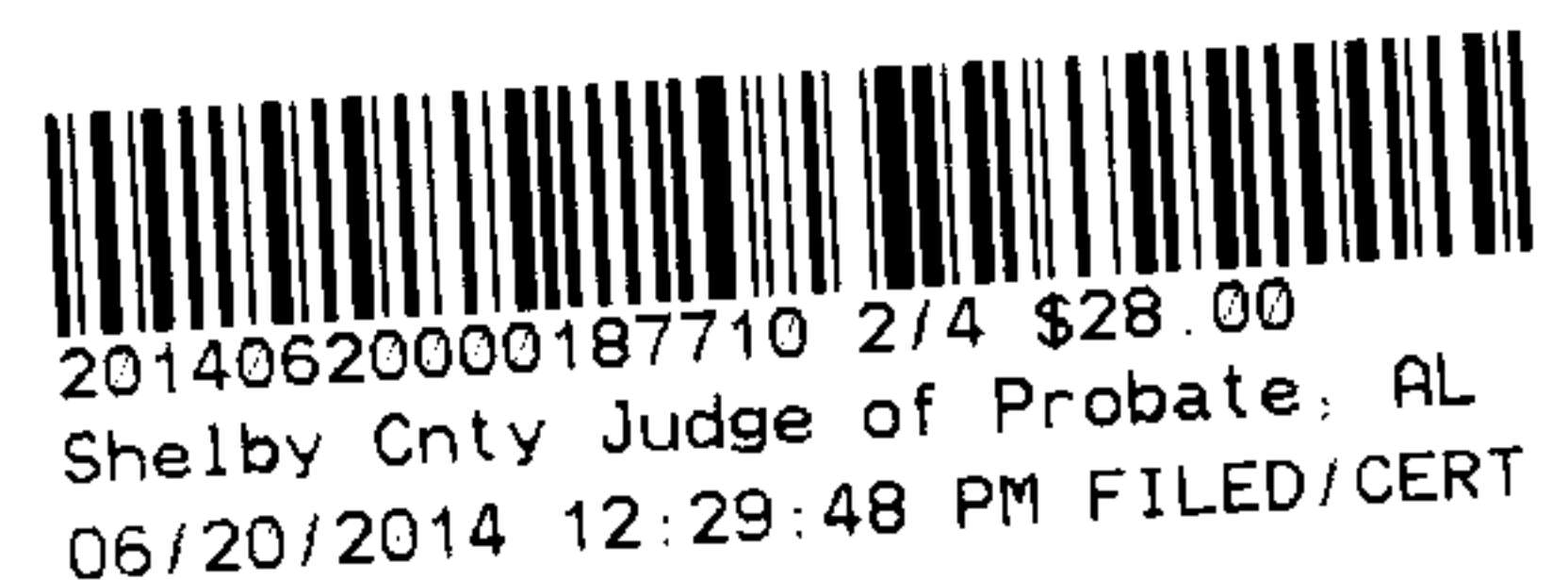

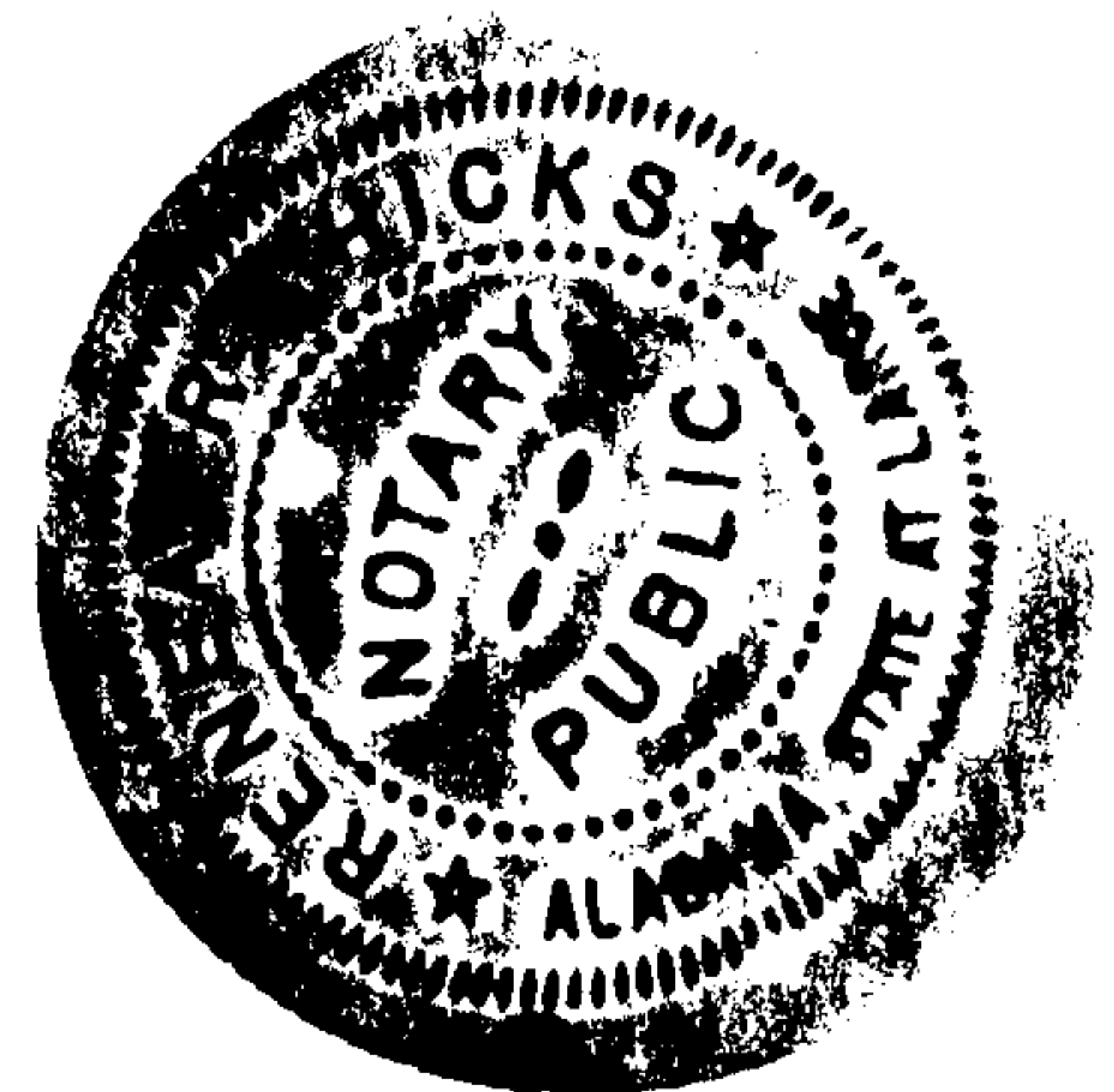
