KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 29th day of May, 2003, Dustin T. Marchand and Renee Marchand, husband and wife, executed that certain mortgage on real property hereinafter described to Liberty Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20030611000366010; having been re-recorded in Instrument Number 20031119000760480, said mortgage having subsequently been transferred and assigned to CitiMortgage, Inc., by instrument recorded in Instrument Number 20140303000057390, in the aforesaid Probate Office ("Transferee"); and

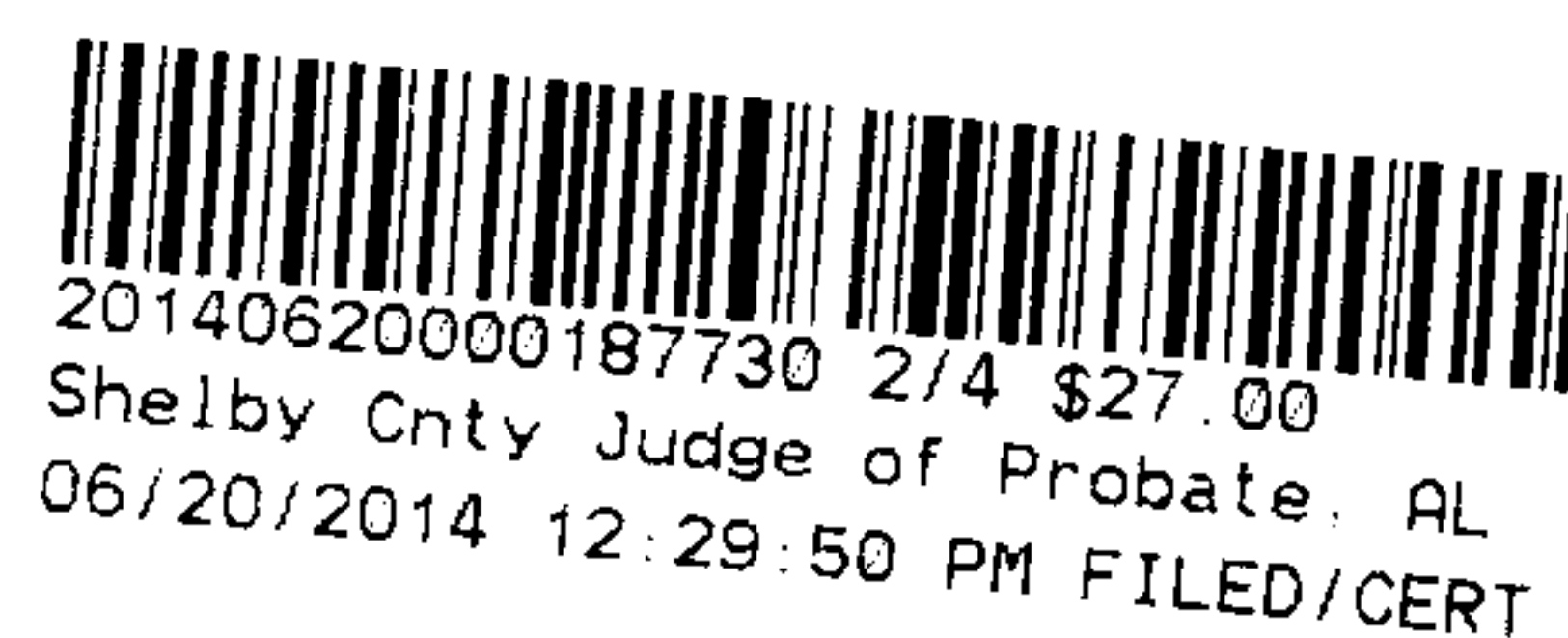

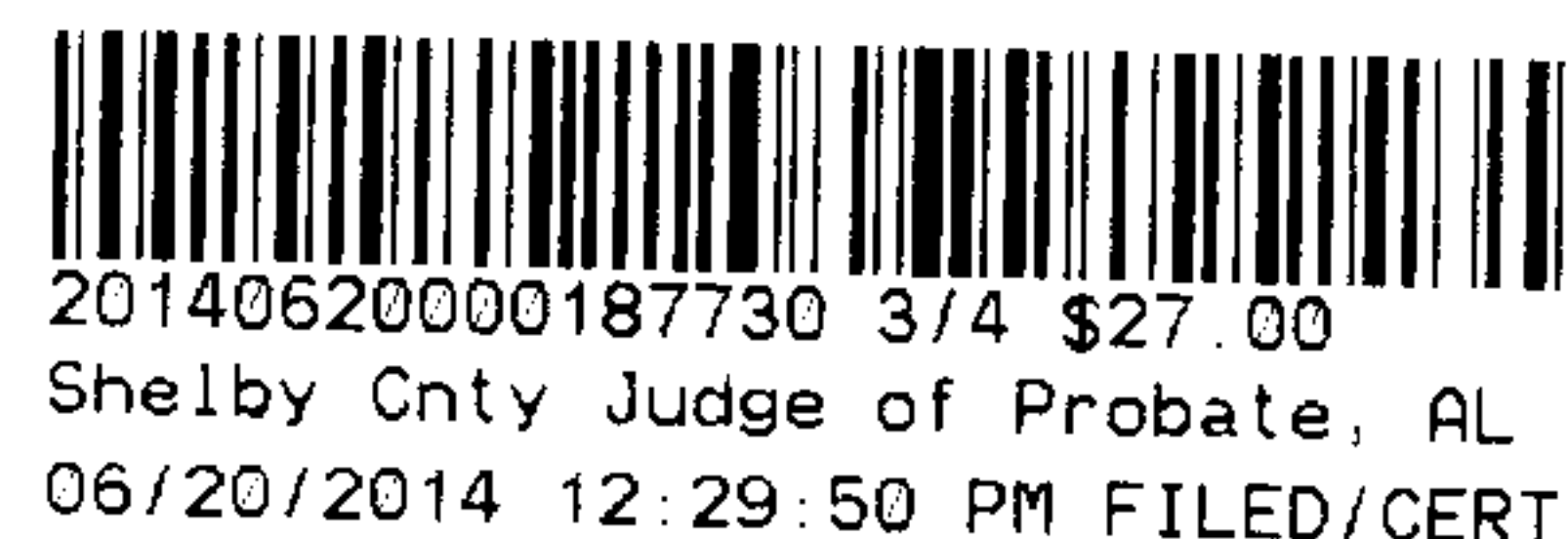
