

ARTICLES OF AMENDMENT  
TO THE

Pursuant to Section 10A-5-2.03 of the Code of Alabama (1975), as amended, Montevallo Thrift Store, L.L.C. hereby amends its Articles of Organization as follows:

- (b) deleting any and all references to Montevallo Thrift Store, L.L.C. and substituting in lieu thereof Rita Is My Realtor, LLC.

FOURTH: This amendment was approved by the sole member of the Company in accordance with its Articles of Organization and Operating Agreement, as amended to date, and applicable law.
