Know all Men by these Presents: That, in consideration of Eighty Five Thousand and No/100ths Dollars (\$85,000.00) and other good and valuable consideration to them in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **BRANDY L. PRICE, a married person AND MARY STANLEY MITCHELL, a married person** (herein referred to as "Grantors") do by these presents grant, bargain, sell and convey unto **RICKY PRICE AND JACKIE DAVIS** (herein referred to as "Grantees") for and during their joint lives and, upon the death of either of them, then to the survivor, in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 181, a Resurvey of Lot 181, according to the Survey of Camden Cove, Sector 1, as recorded in Map Book 30, page 72, in the Probate Office of Shelby County, Alabama.



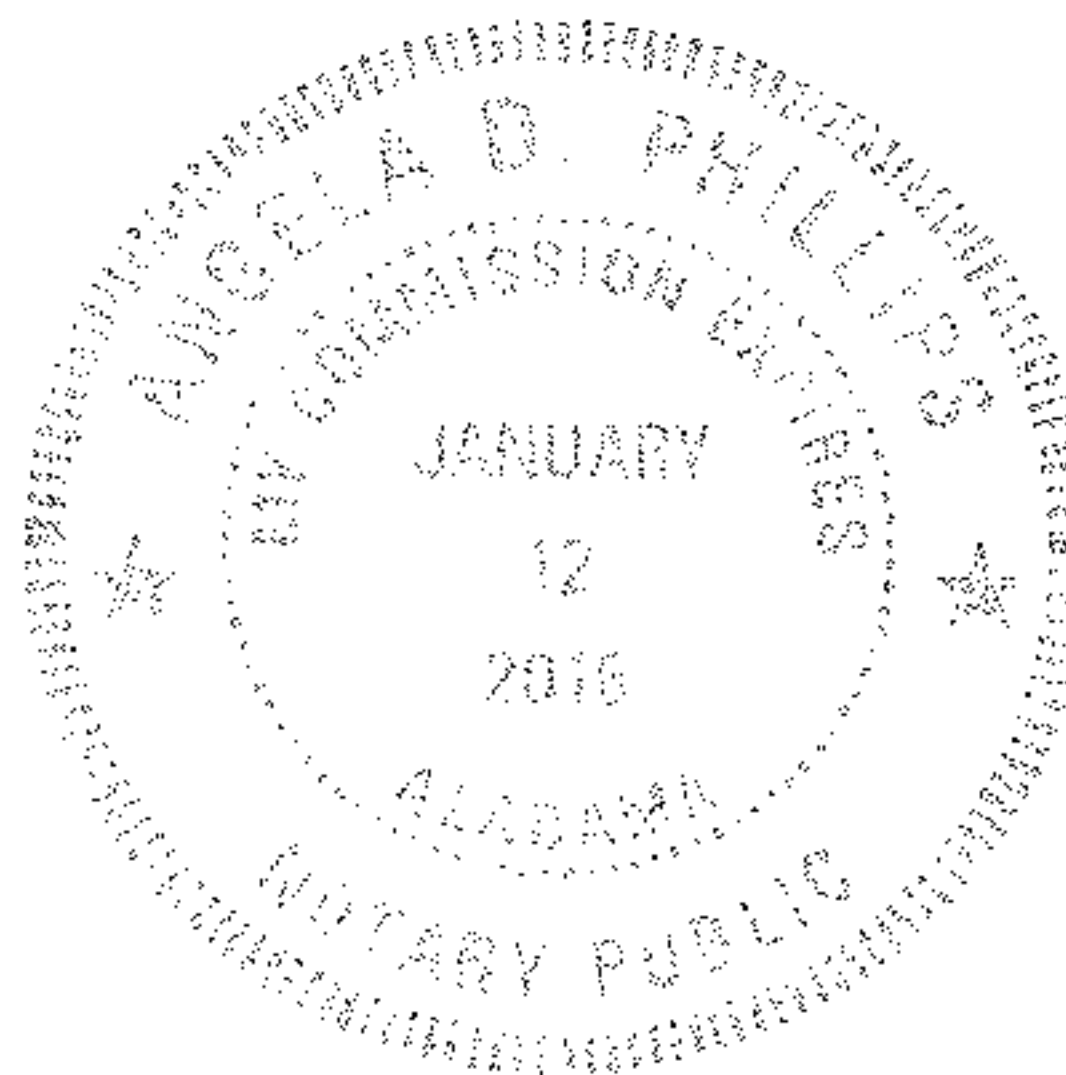


