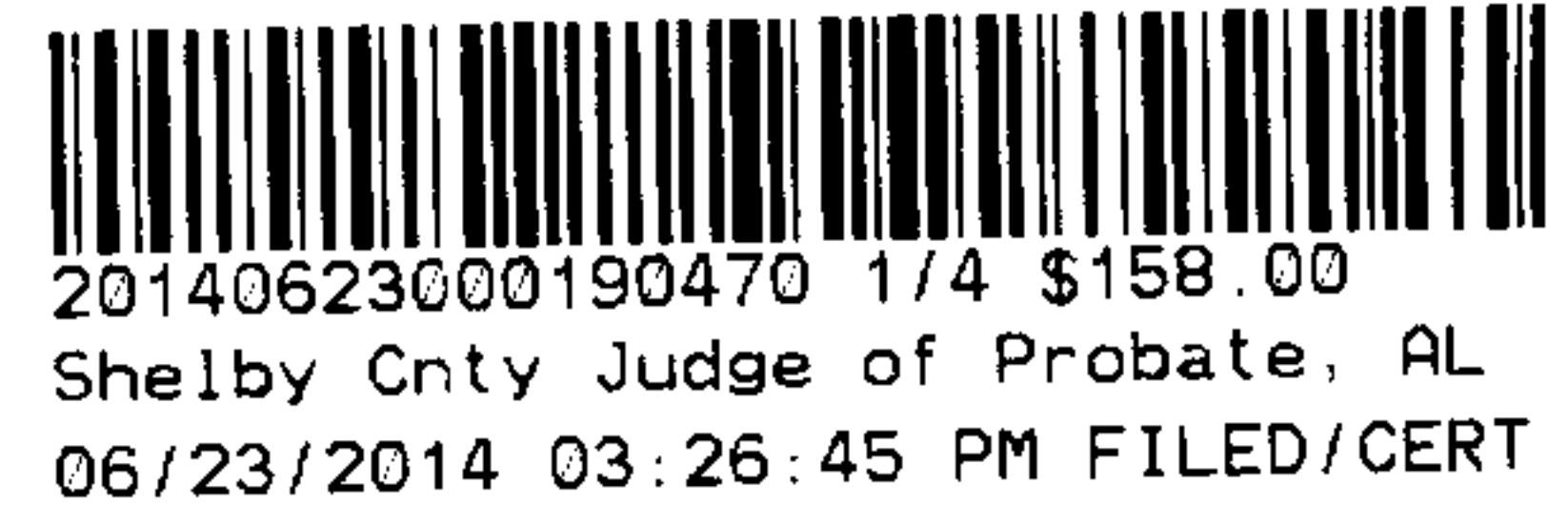

ARTICLES OF ORGANIZATION

OF

RIDGE CREST HOMES, LLC



The undersigned, a natural person over the age of eighteen (18) years, acting as Organizer of a limited liability company under the Alabama Limited Liability Company Act, does hereby adopt the following Articles of Organization for such limited liability company.

ARTICLE ONE

NAME

The name of the limited liability company is **Ridge Crest Homes, LLC**.

ARTICLE TWO

DURATION

The period of the limited liability company's duration is until expiration of the period fixed for duration of the Company from time to time, the unanimous written consent of all Members or until the earlier dissolution of the company in accordance with the provisions of the company's regulations.

ADMISSION OF NEW MEMBERS


