

**CERTIFICATION OF TRUST

1. The Kathleen A. Weidenbaum Trust created under the Frank H. Michaels Living Trust dated January 18, 1995 is a valid, existing trust, having been created by Trust Agreement upon the death of Frank H. Michaels on August 7, 2013.

  - A. The original settlor of the trust is Frank H. Michaels.
  - B. The following person(s) contributed money, funds, real property, or personal property to the trust: Frank H. Michaels and Myerna J. Michaels.
  - C. The name and address of the currently acting trustees are KATHLEEN A. WEIDENBAUM, 748 N.W. Macleay Blvd, Portland, OR 97210 and LAURA M. GRAHAM, 2134 Brookhighland Ridge, Birmingham, AL 35242).
3. The administrative and/or managerial powers of the trustee include:

My Trustee may purchase, sell, transfer, exchange or otherwise acquire or dispose of any real estate.

My Trustee may make leases and grant options to lease for any term, even though the term may extend beyond the termination of any trust created under this agreement.

My Trustee may grant or release easements and other interests with respect to real estate; enter into party wall agreements, execute estoppel certificates, and develop and subdivide any real estate.

My Trustee may dedicate parks, streets, and alleys or vacate any street or alley; construct, repair, alter, remodel, demolish, or abandon improvements.

My Trustee may elect to insure, as it deems advisable, all actions contemplated by this subsection.

My Trustee may take any other action reasonably necessary for the preservation of real estate and fixtures comprising a part of the trust property or the income therefrom.

5. The trust is irrevocable.
6. A. The following trustees have the authority to sign documents and instruments: Kathleen A. Weidenbaum and Laura M. Graham.
- B. Both Trustees are required to sign.
7. Trust Property should be titled as follows:
- Kathleen A. Weidenbaum and Laura M. Graham, Trustees of the Kathleen A. Weidenbaum Trust created under the Frank H. Michaels Living Trust dated January 18, 1995.
8. To the best of the undersigned's knowledge, the trust has not been revoked, modified, or amended in any manner that would cause the representations and statements contained herein to be incorrect.


