Pursuant to the provisions of the Alabama Business Corporation Act, the undersigned hereby adopts the following Articles of Incorporation.

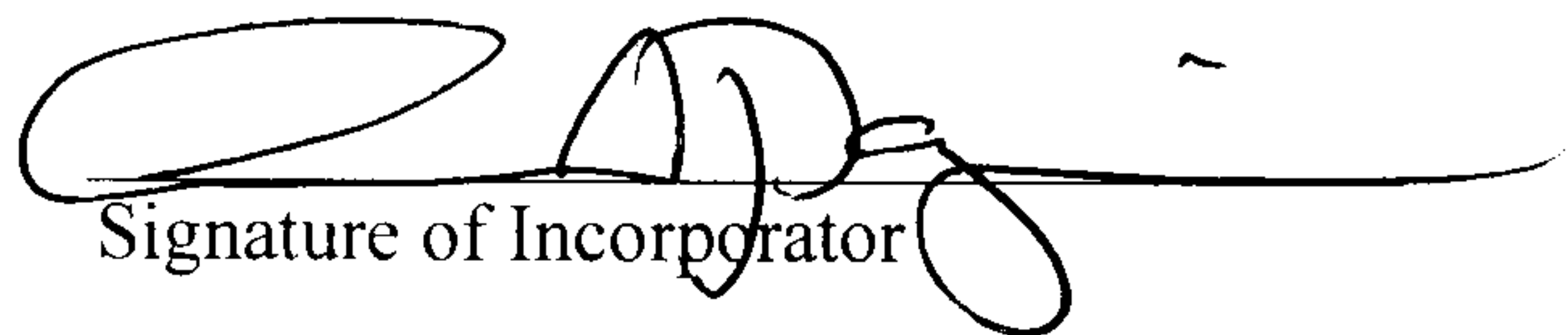
- Article I The name of the corporation is OOPS! Repair, Inc.

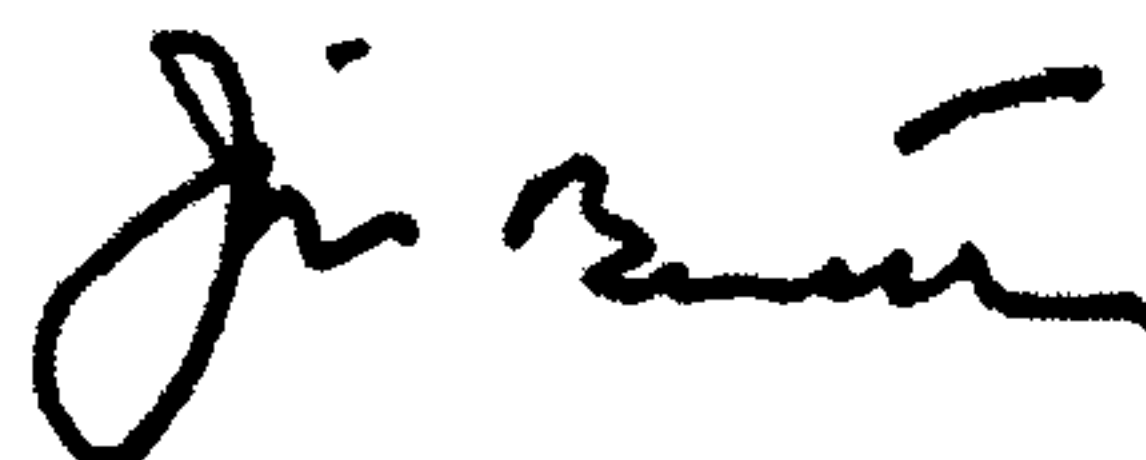
