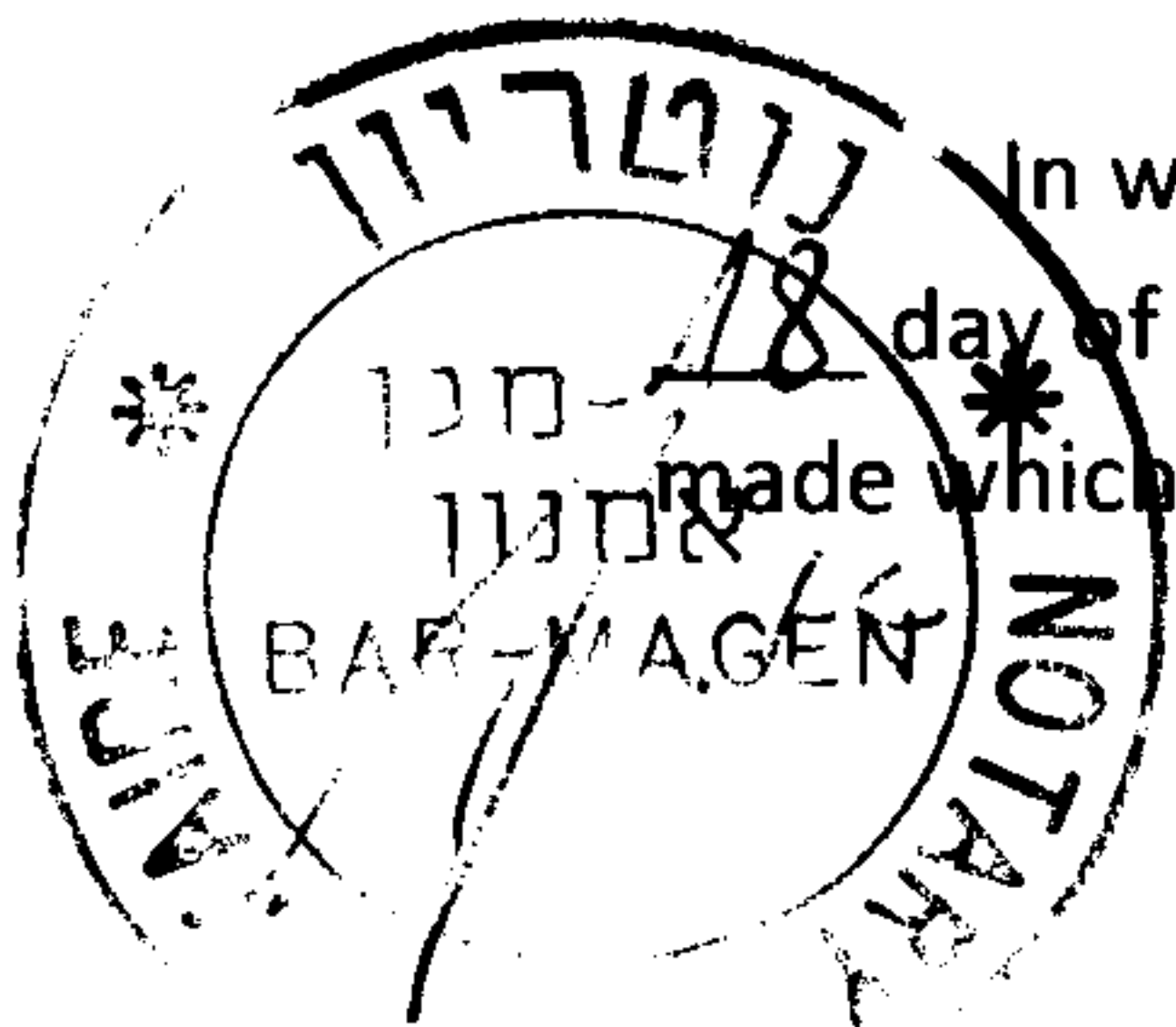
To execute any and all documents pertaining to the sale of real property known as:

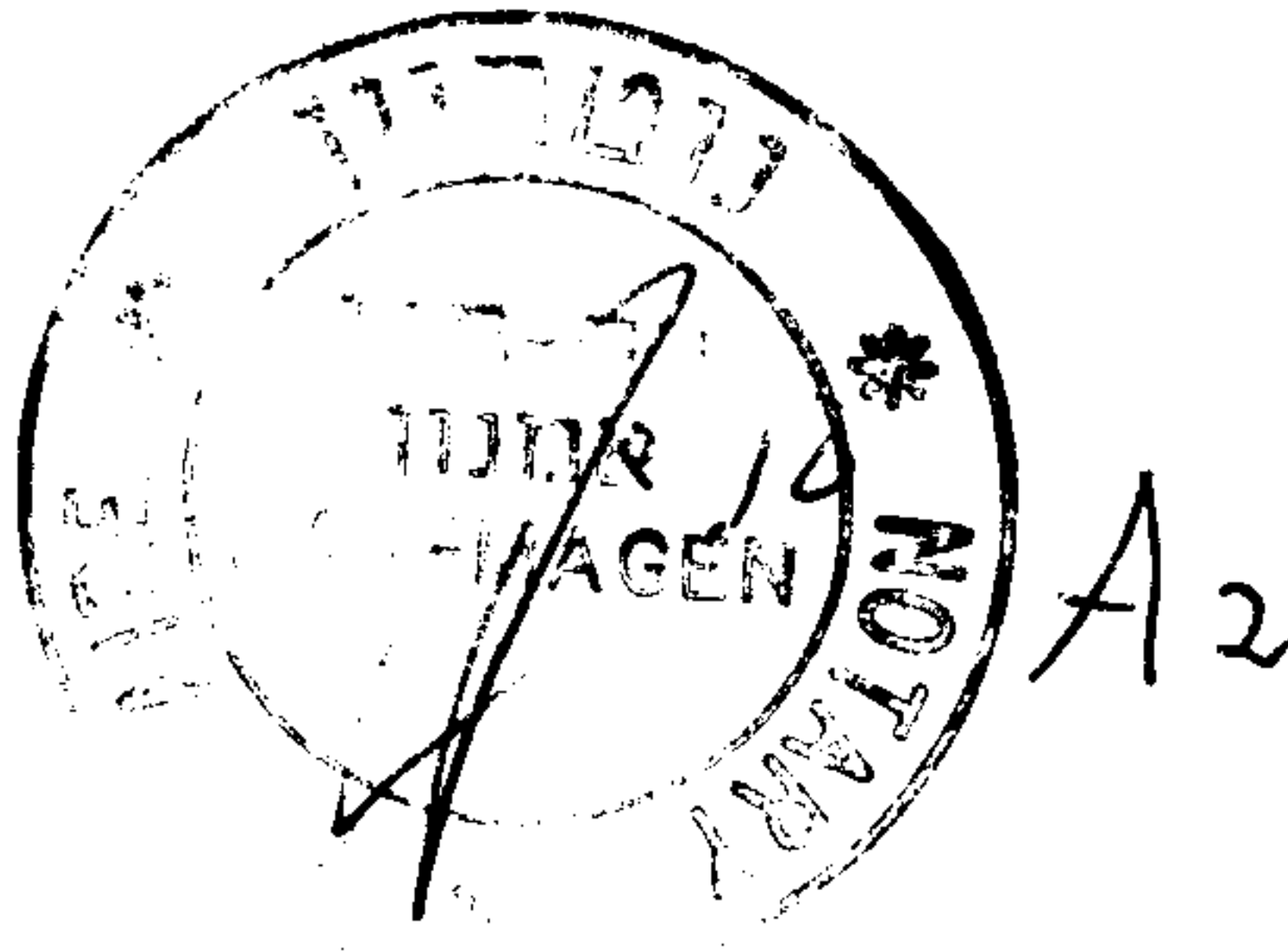

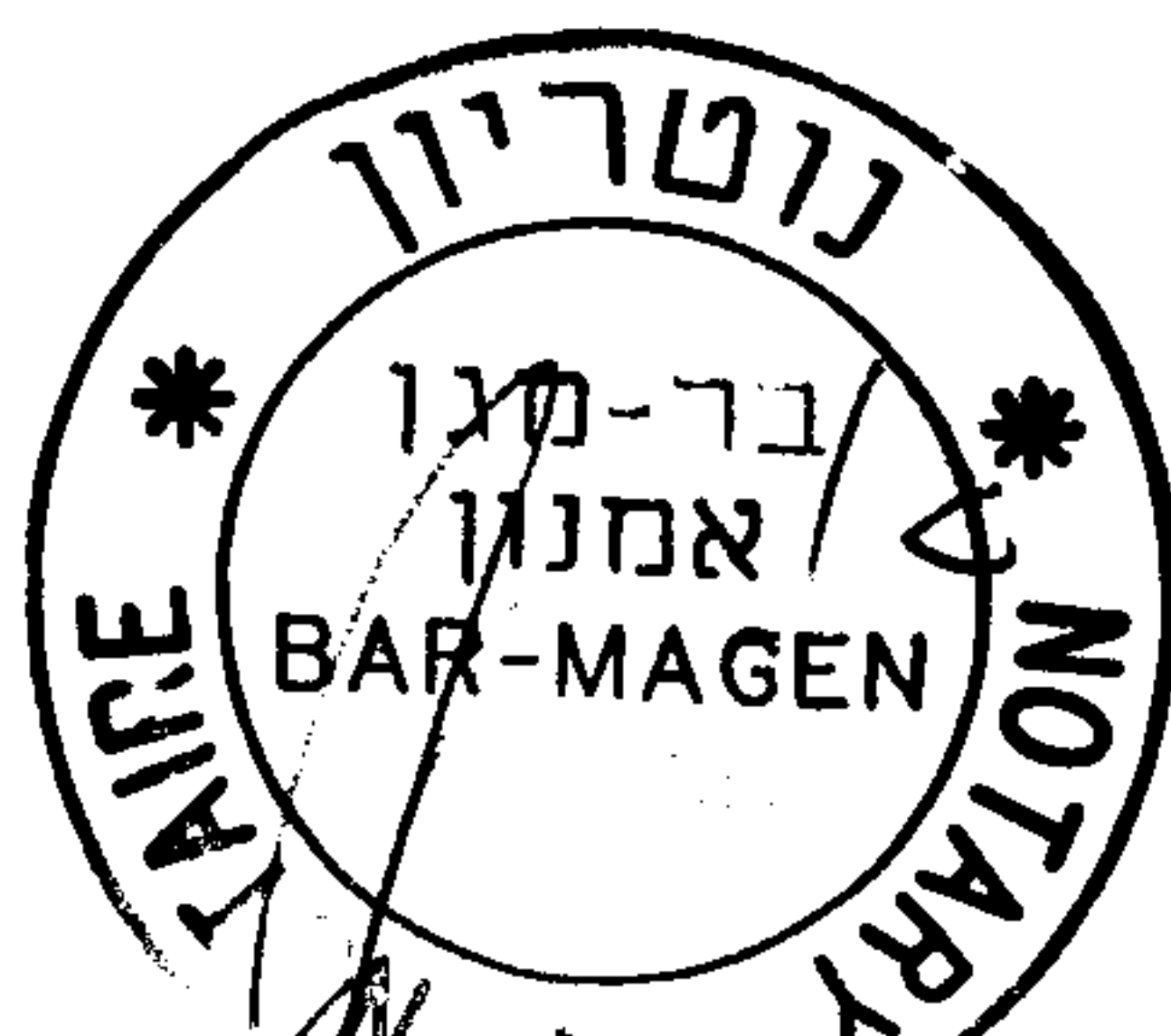

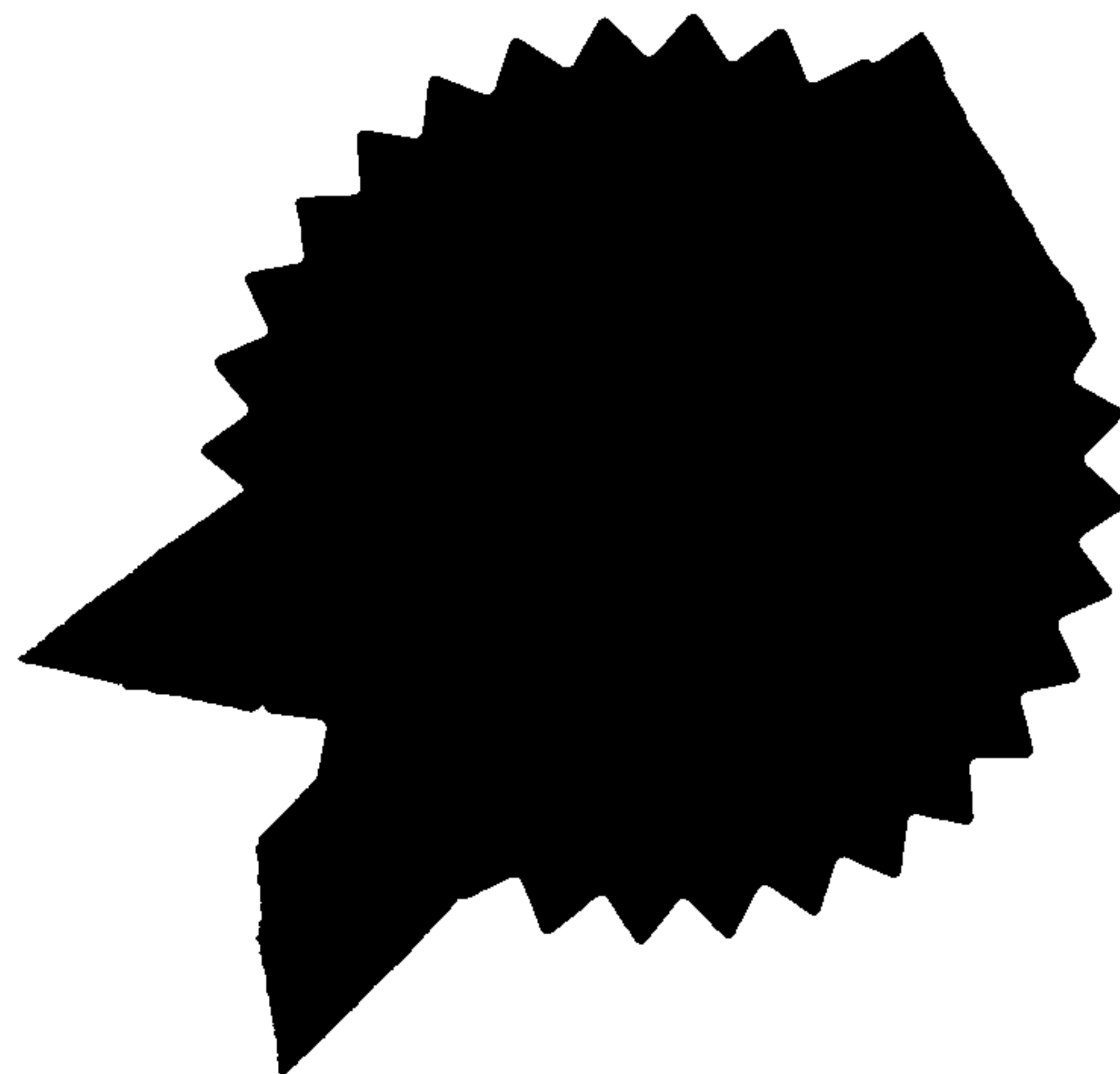
