FORECLOSURE DEED

KNOWN ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore on, to-wit, **05/27/2003, KENNETH M. EARLY AND MELANIE A. EARLY, HUSBAND AND WIFE**, as Mortgagors, executed a Real Estate Mortgage on the property hereinafter described to **CHARTER ONE MORTGAGE CORP.** which is recorded as Instrument Number 20030603000342530, in the Office of the Judge of Probate, SHELBY County, Alabama on 06/03/2003 and subsequently assigned to RBS CITIZENS, N.A. and recorded as Instrument Number 20140407000098480 on 04/07/2014, and,

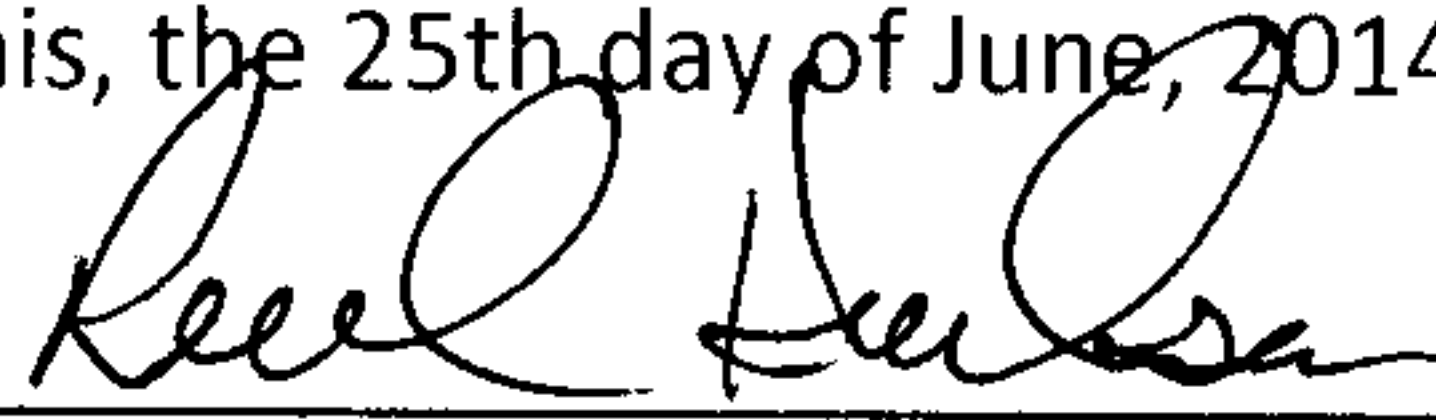

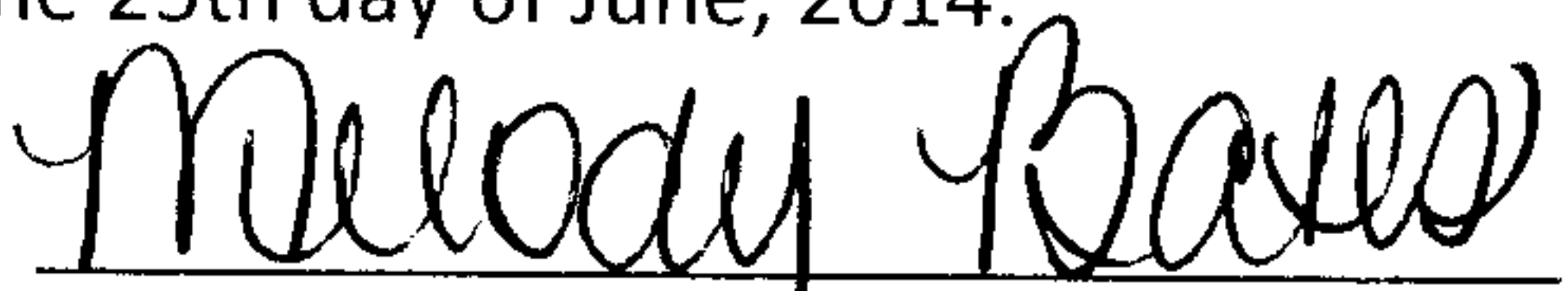
