## **WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP**

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **Four Hundred Sixty-Five Thousand Nine Hundred Sixty-Eight and 00/100 Dollars (\$465,968.00)** to the undersigned grantor in hand paid by the grantees herein, the receipt whereof is acknowledged,

(hereinafter referred to as "Grantor") does grant, bargain, sell and convey unto

**Dylan D. Myrick and Alexandria B. Myrick**

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby County, Alabama** to-wit:

**Lot 4, according to the Final Record Plat of Heatherwood, 7th Sector, as recorded in Map Book 39, Page 84 A & B, in the Probate Office of Shelby County, Alabama**


**\$417,000.00** of the proceeds come from a mortgage recorded simultaneously herewith.


