WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

STATE OF ALABAMA SHELBY COUNTY

KNOW ALL MEN BY THESE PRESENTS

That in consideration of Four Hundred Sixty-Five Thousand Nine Hundred Sixty-Eight and 00/100 Dollars (\$465,968.00) to the undersigned grantor in hand paid by the grantees herein, the receipt whereof is acknowledged,

(hereinafter referred to as "Grantor") does grant, bargain, sell and convey unto

Dylan D. Myrick and Alexandria B. Myrick

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

Subject to:

- all mineral and mining rights not owned by the Grantor; and
- all easements, rights-of-way, restrictions, covenants and encumbrances of record.
