

**SPECIFIC POWER OF ATTORNEY**

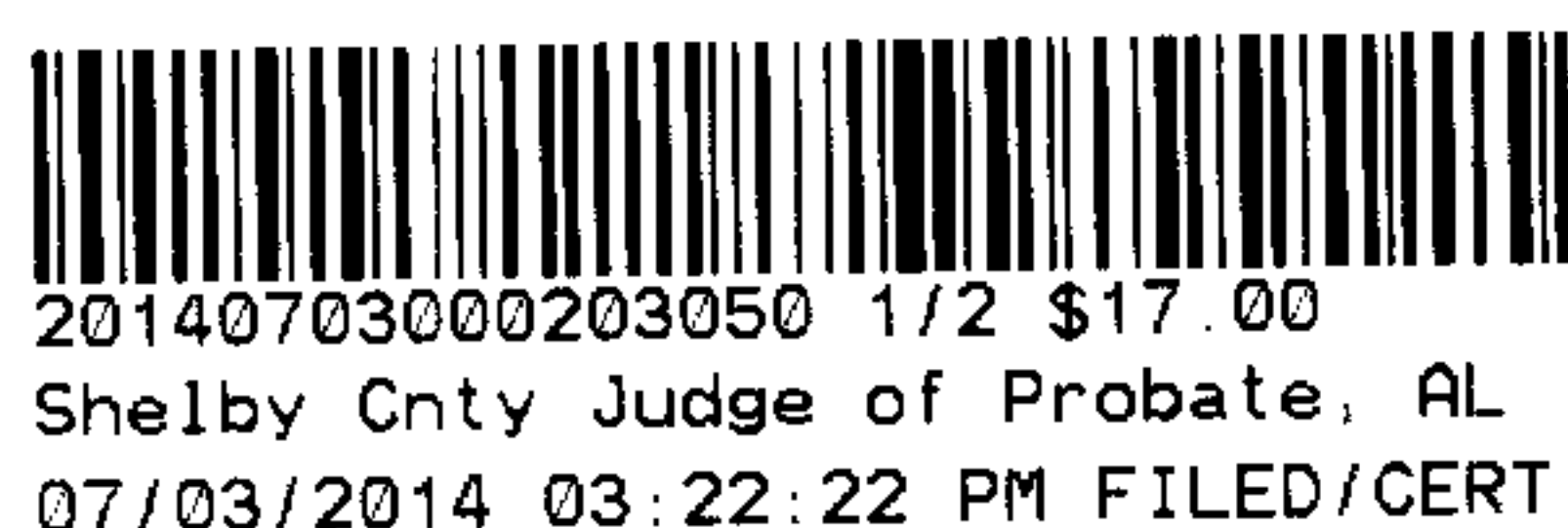
