**KNOW ALL MEN BY THESE PRESENTS,** That in consideration of the sum of One Hundred Eighty-Nine Thousand Nine Hundred And No/100 Dollars (\$189,900.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Michael B. Finch and wife, Morgan Finch (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Lewis F. Golden, Jr. and Brenda M. Golden (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Lot 178, according to the Final Subdivision Plat of Holland Lakes, Sector 3, as recorded in Map Book 37, Page 85, in the Probate Office of Shelby County, Alabama.
