KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 31st day of October, 2011, Diana M. Rodriguez, a married woman and husband, Joseph A. 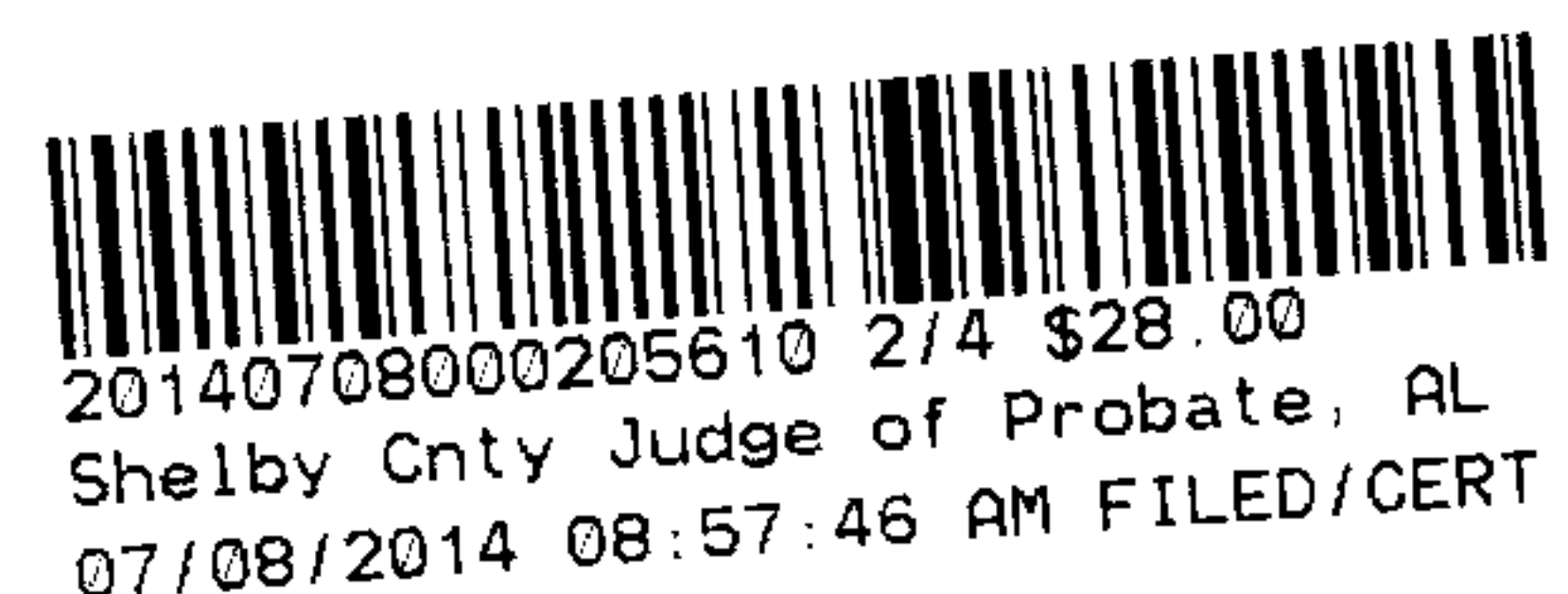

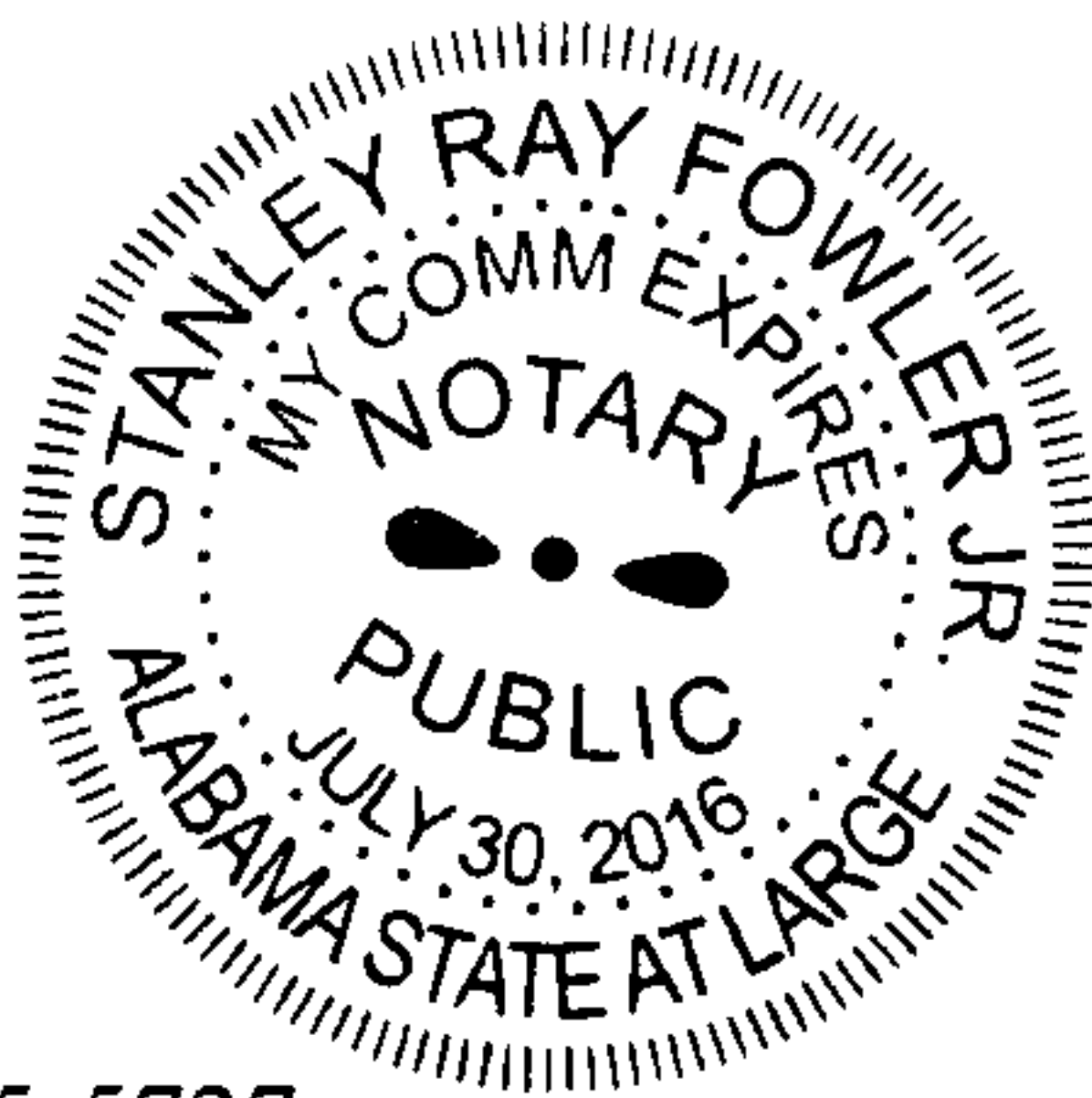

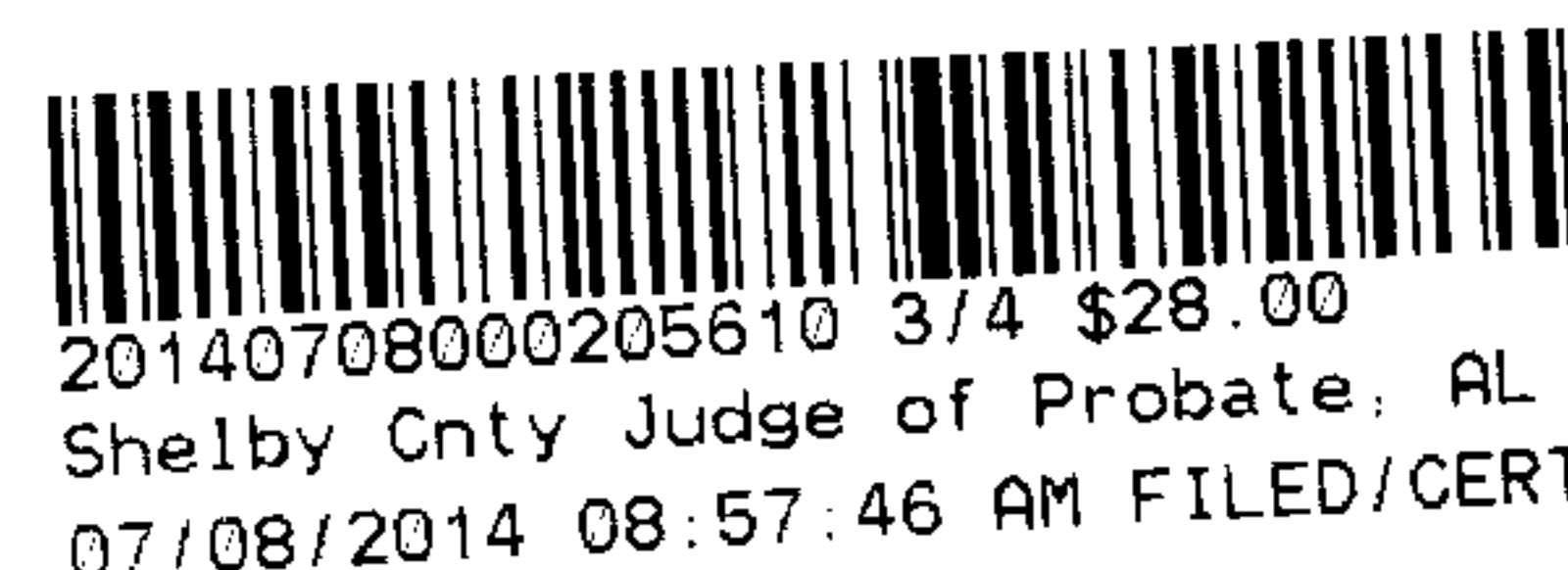
