

FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on October 25, 2002, towit: Brian Blake Gothard Sr., and Christy D. Gothard, husband and wife, executed a mortgage to Southpoint Financial Services, Inc., its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on November 5, 2002, in Document Number 20021105000547650, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to US BANK NATIONAL ASSOCIATION AS TRUSTEE FOR CFMSI REMIC SERIES 2003-02 - REMIC PASS-THROUGH CERTIFICATES SERIES 2003-02, by assignment recorded February 14, 2014, and recorded in Document Number 20140214000041940, Probate Records of Shelby County, Alabama; and
