ARTICLE ONE

To buy, sell, lease, hold, improve and otherwise deal in real and personal property, including securities; to lend and borrow money, with or without interest, with or without security therefore, but nothing contained herein shall be construed to empower this limited liability company to be of a banking, trust or insurance nature.


