

ARTICLES OF ORGANIZATION
OF
SMW ENGINEERING GROUP, N.C., LLC

Pursuant to Section §10-12-1, Code of Alabama (1975) *et seq.*, the undersigned hereby adopts the following Limited Liability Company Articles of Organization:

ARTICLE I - NAME

The Name of the Limited Liability Company shall be **SMW Engineering Group N.C., LLC** (the "Company").

ARTICLE II - DURATION

The period of duration of the Company shall be perpetual, unless it is dissolved and its affairs wound up in accordance with the Alabama Limited Liability Company Act (the "Act").

ARTICLE III - PURPOSES

The Limited Liability Company has been organized to engage in the business of providing engineering and construction services, all related activities thereto, and any other lawful business the members shall reasonably decide to pursue. The Limited Liability Company shall have all powers permitted by the Act, as amended from time to time.

ARTICLE IV - REGISTERED AGENT/OFFICER

The location and street address of the initial registered office shall be 158 Business Center Drive Birmingham, AL 35244, and its registered agent at such address shall be Andrew A. Kramer.

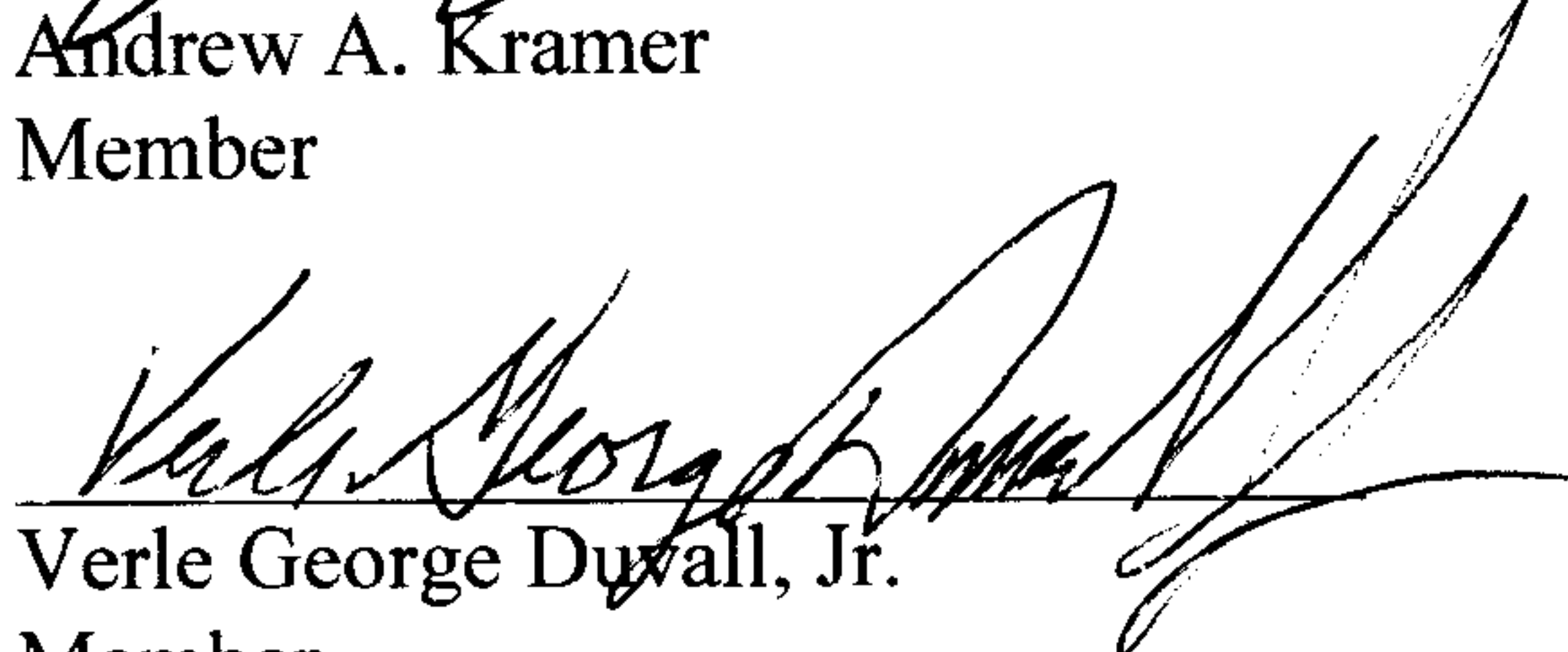

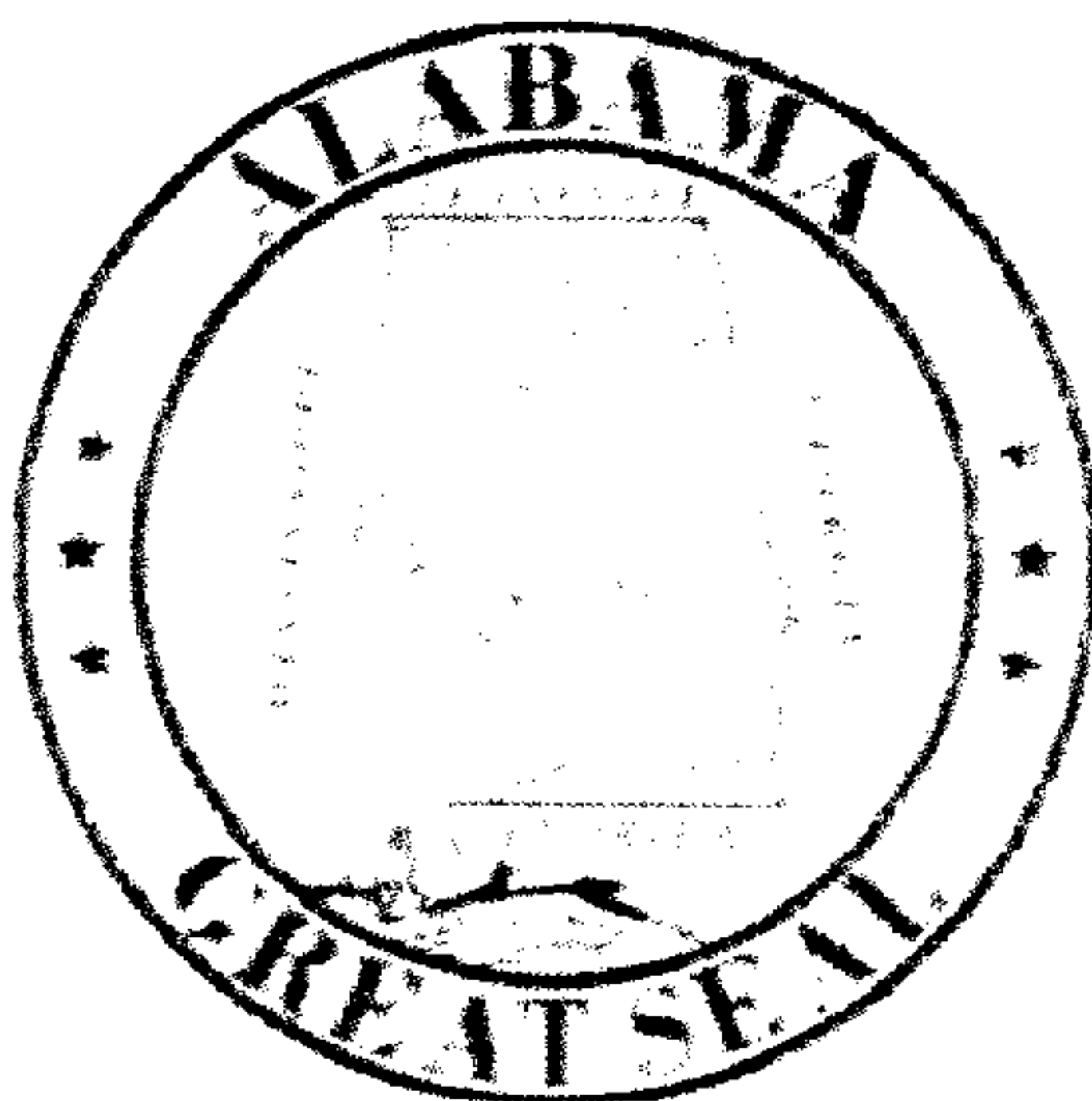
