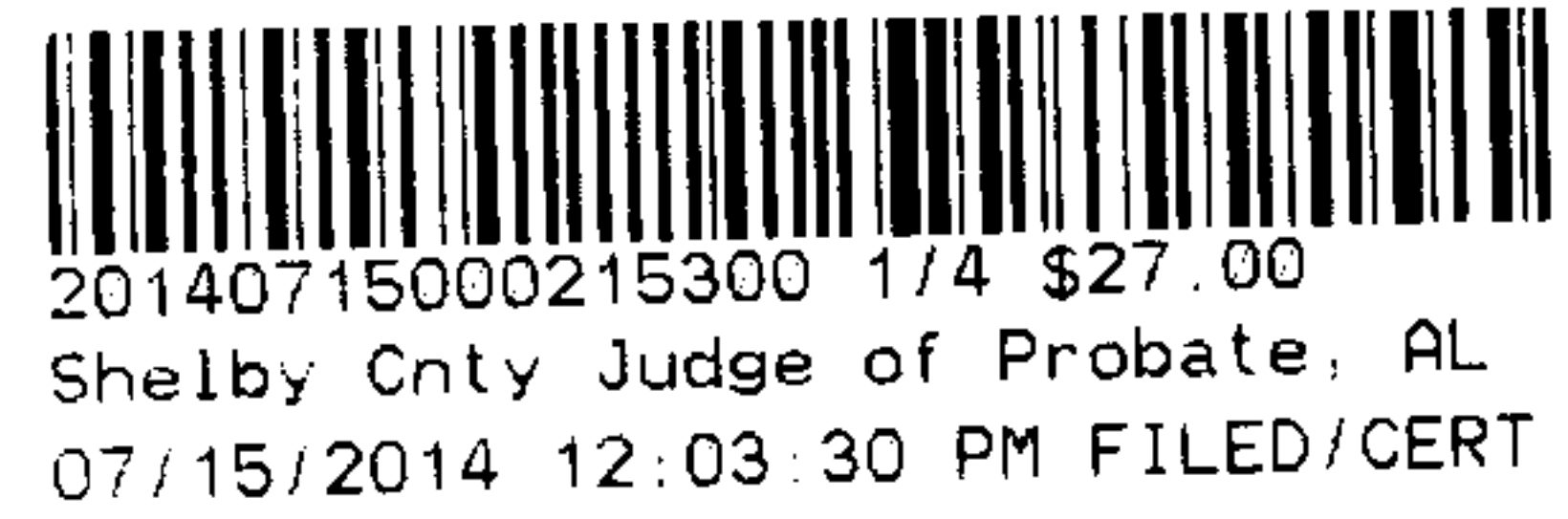

**FORECLOSURE DEED**



KNOW ALL MEN BY THESE PRESENTS, that:

WHEREAS, heretofore, on, to-wit: the 24th day of June, 2009, Alicia R. Thomas, an unmarried woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for Synovus Mortgage Corp., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, as Instrument Number 20090708000263000, said mortgage having subsequently been transferred and assigned to NRZ Pass-Through Trust I, U.S. Bank National Association as trustee ("Transferee"), by instrument executed on March 25, 2014 and recorded on April 14, 2014 in Instrument 20140414000107920, in the aforesaid Probate Office; and

WHEREAS, NRZ Pass-Through Trust I, U.S. Bank National Association as trustee, was the highest bidder and best bidder in the amount of One Hundred Twenty-Nine Thousand Sixty-Eight and 71/100 Dollars (\$129,068.71) on the indebtedness secured by said mortgage, the said NRZ Pass-Through Trust I, U.S. Bank National Association as trustee, by and through David Sigler as attorney for said Transferee, does hereby convey unto NRZ Pass-Through Trust I, U.S. Bank National Association as trustee all of its right, title, and interest in and to the following described property situated in Shelby County, Alabama, to-wit:
