KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 18th day of February, 2004, Shalom C. Hillers, an unmarried woman, executed that certain mortgage on real property hereinafter described to Mortgage Professionals, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20040225000095810, said mortgage having subsequently been transferred and assigned to Trustmark National Bank, by instrument recorded in Instrument Number 20040225000095820, in the aforesaid Probate Office ("Transferee"); and

WHEREAS, default was made in the payment of the indebtedness secured by said mortgage, and the said Trustmark National Bank did declare all of the indebtedness secured by said mortgage, subject to foreclosure as therein provided and did give due and proper notice of the foreclosure of said mortgage by



publication in the Shelby County Reporter, a newspaper of general circulation published in Shelby County, Alabama, in its issues of May 14, 2014, May 21, 2014, and May 28, 2014; and

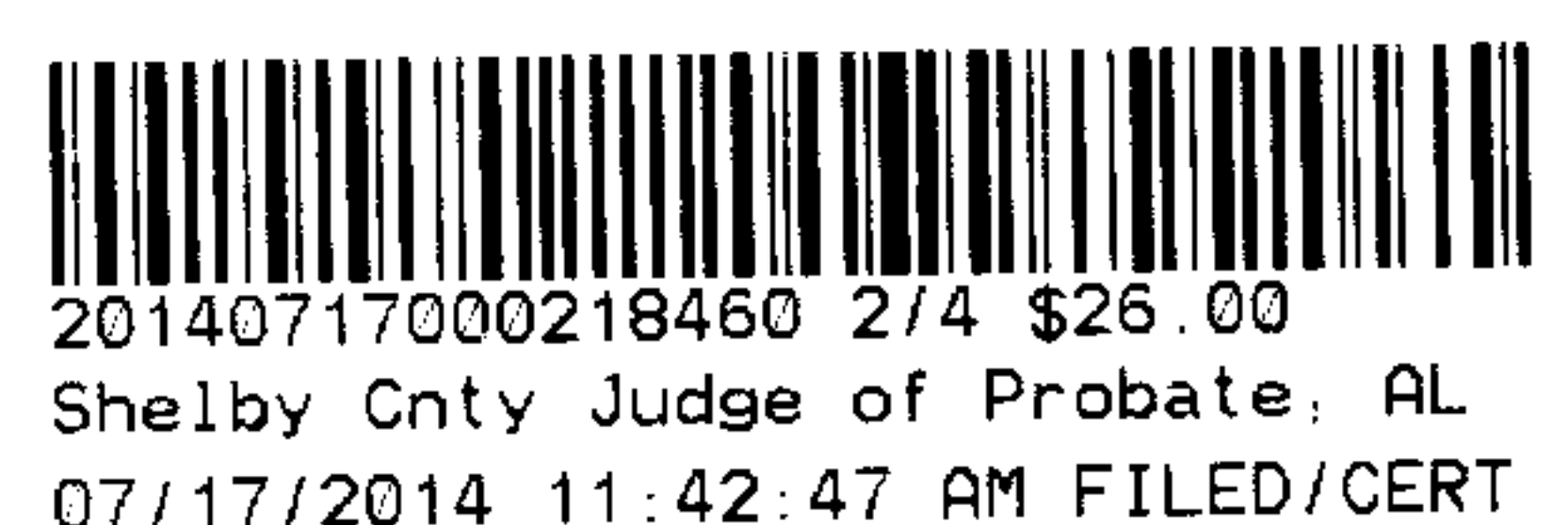

Lot 28, according to the Final Plat Park Forest Village, as recorded in Map Book 31, Page 51, in the Probate Office of Shelby County, Alabama.

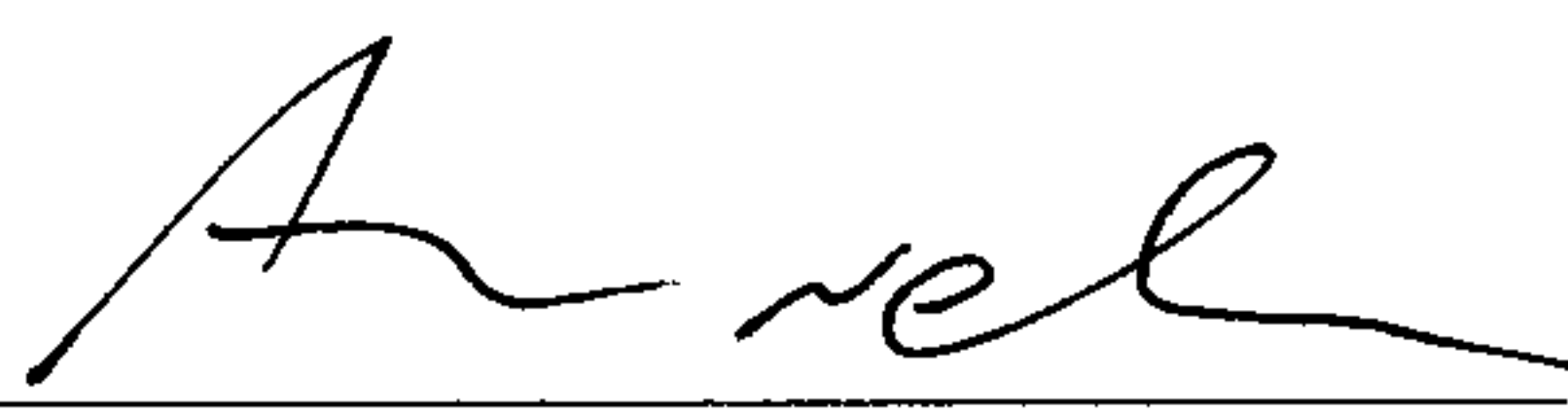
