



THIS 1-4 FAMILY MODIFICATION AGREEMENT RIDER ASSIGNMENT OF RENTS ("1-4 Family Rider") effective 3/25/2014, is incorporated into that certain Loan Modification Agreement (the "Modification") of the same date made by Sam Mollica Susan Mollica (the "Borrower") and is incorporated into and amends and supplements the Security Instrument executed by Borrower to secure the Note. 


