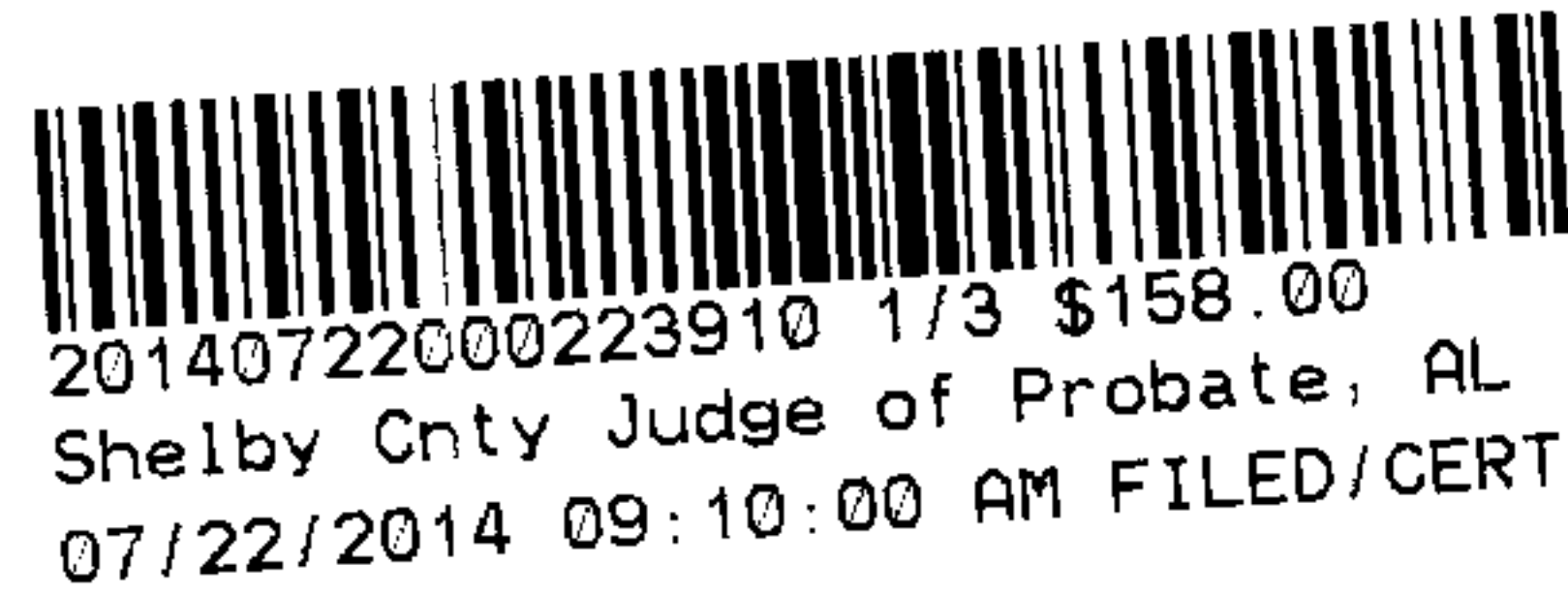

ARTICLES OF ORGANIZATION

Pursuant to the provisions of the Alabama Limited Liability Company Act, the undersigned do hereby adopt and authorize the filing of these Articles of Organization, with the following provisions:

ARTICLE I If)

NAME

The name of the Limited Liability Company is MCDOWELL SECURITY SERVICES, LLC (the "Company").

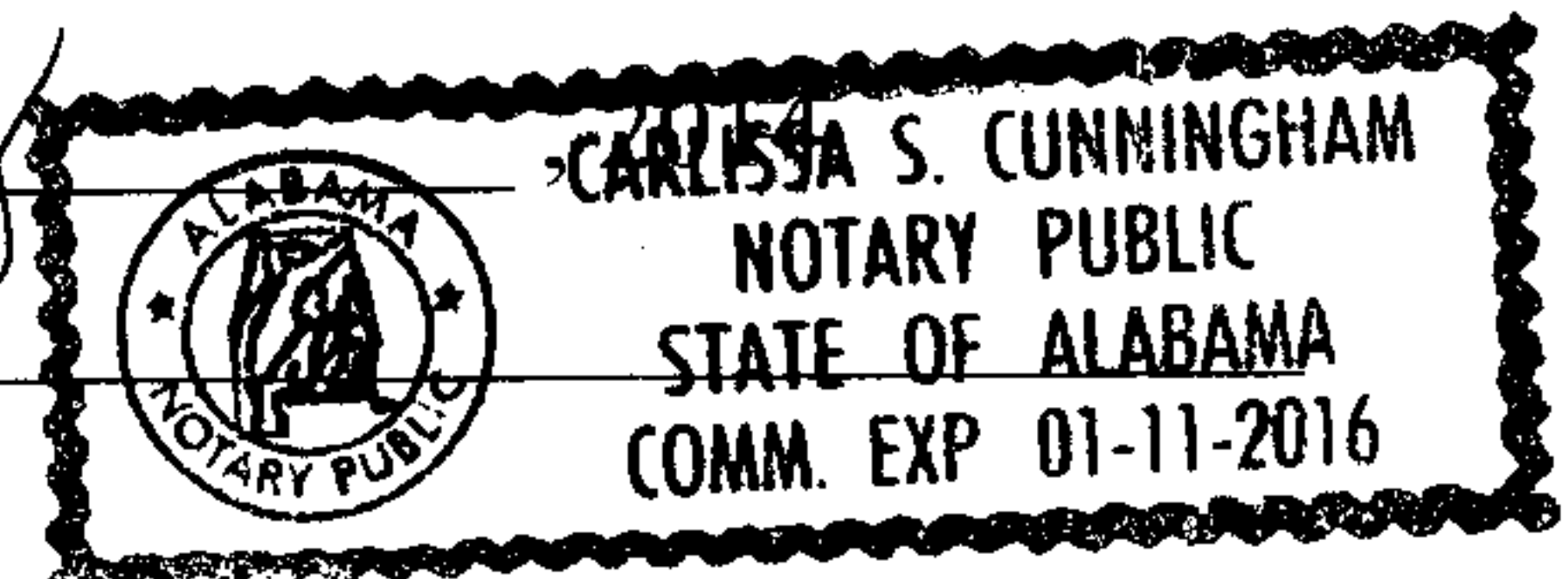
