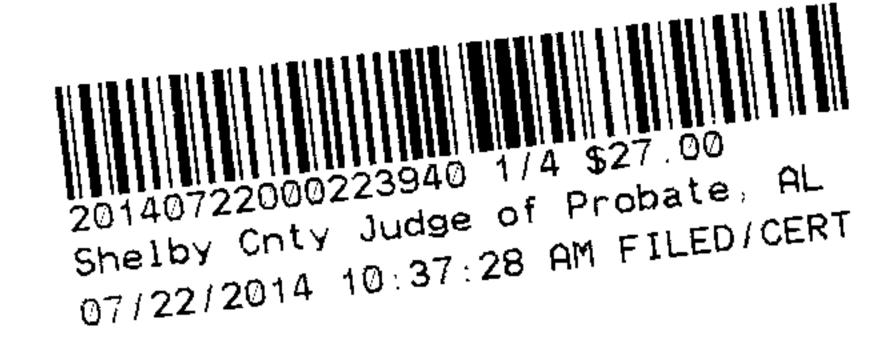

WHEREAS, heretofore, on, to-wit: the 22nd day of December, 2006, Beverly L. 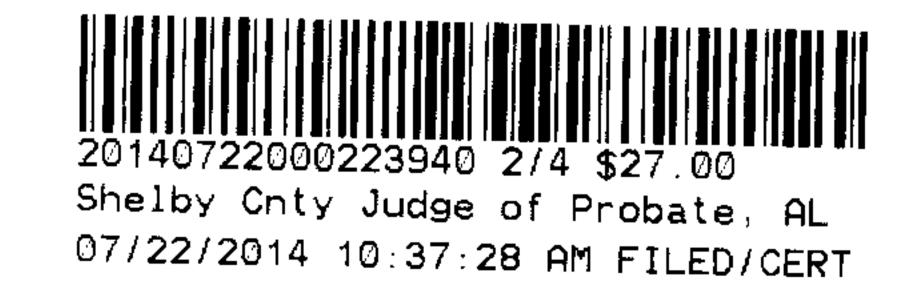

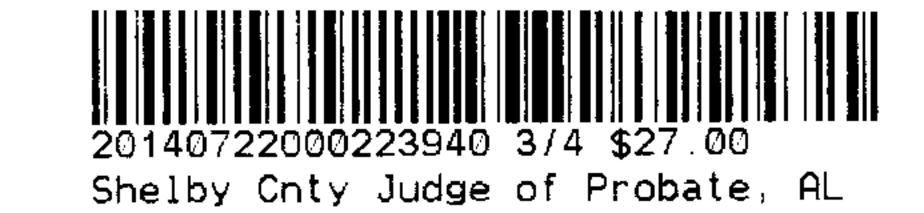
