KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 5th day of October, 2006, Hubert J. Chapman and Tracy D. Chapman, his wife, executed that certain mortgage on real property hereinafter described to First Financial Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20061026000528630, said mortgage having subsequently been transferred and assigned to CitiMortgage, Inc., by instrument recorded in Instrument Number 20061026000528640, in the aforesaid Probate Office ("Transferee"); and

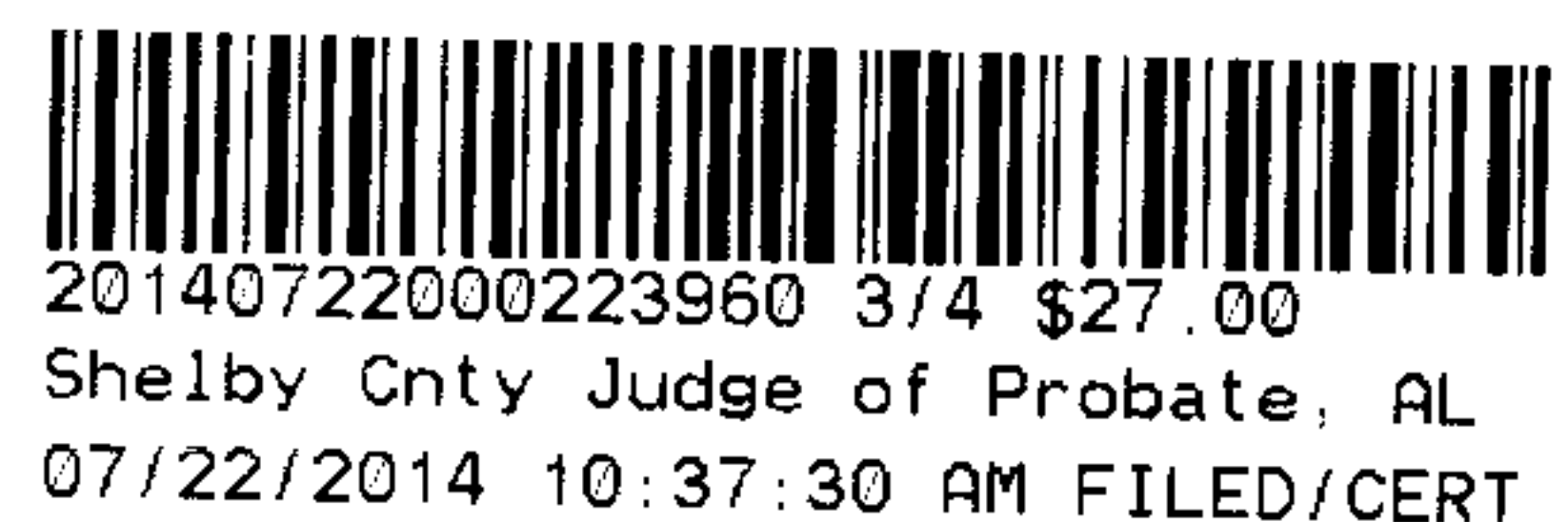
